#### BASIC SERVICES OF FUNERAL DIRECTOR AND STAFF

Our Basic Service Charge includes, but is not limited to, staff to respond to initial request for service; arrangement conference with family or responsible party; preparation and filing of necessary certificates and permits; shelter of remains; placement of obituary notices; planning of funeral arrangements; and coordination of service with cemetery, crematory, vault companies, and others as required. Also included in this charge are overhead expenses relative to our facility such as insurance, maintenance and utility expenses, secretarial and administrative costs, and equipment and inventory expenses.

This fee for our basic services and overhead will be added to the total cost of the funeral arrangements you select. (This fee is already included in our charge for Direct Cremations, Immediate Burials, and Forwarding or Receiving Remains.) **(NON-DECLINABLE CHARGE)**

#### EMBALMING

**\$ 1250.00**

Embalming is not required by law. Embalming may be necessary, however, if you select certain funeral arrangements, such as a funeral with viewing. If you do not want embalming, you usually have the right to choose an arrangement that does not require you to pay for it, such as Direct Cremation or Immediate Burial.

**IMMEDIATE BURIAL** \$ 3145.00 TO \$ 9250.00

Our charge for Immediate Burial which does not include visitation, rites, or ceremonies includes Basic Services of Funeral Director and Staff; a proportionate share of overhead costs; removal of remains; and local transportation to cemetery.

1. Immediate Burial with merchandise provided by purchaser (all such merchandise must meet any applicable state or cemetery requirements). \$ 3145.00
2. Immediate Burial with casket selected from our Funeral Home. (In addition to cost of casket) \$ 3145.00
3. Immediate Burial with Light Weight Steel Casket selected from our Funeral Home. \$ 5168.00  
To meet the requirements of Pennsylvania Rules and Regulations 13.201 6 (i) when we hold un-embalmed human remains beyond 24 hours following death.

**FORWARDING OF REMAINS TO ANOTHER FUNERAL HOME** \$ 3400.00

Our charge includes Basic Services of Funeral Director and Staff; a proportionate share of overhead costs; removal of remains; necessary authorizations; embalming or other preparation of remains, if relevant; and local transportation (excluding shipping charges). This charge does not include visitation, rites, or ceremonies.

**RECEIVING REMAINS FROM ANOTHER FUNERAL HOME** \$ 2350.00

Our charge includes Basic Services of Funeral Director and Staff; a proportionate share of overhead costs; care of remains; transportation of remains from funeral home to cemetery or crematory. This charge does not include visitation, rites, or ceremonies.

**DIRECT CREMATION** \$ 2945.00 TO \$ 9234.00

Our charge for a Direct Cremation includes Basic Services of Funeral Director and Staff; a proportionate share of overhead costs; removal of remains; transportation to crematory; necessary authorizations; cremation if relevant; and return of cremains if requested. **This charge does not include visitation, rites, or ceremonies. This charge does not include the crematory fee or Coroner's authorization fee.**

If you want to arrange a Direct Cremation, you can use an alternative container. Alternative containers encase the body and can be made of materials like fiberboard or composition materials (with or without an outside covering). The containers we provide are ***flexible vinyl containers***.
