Explanation of Services

Professional Services \$550.00

- ❖ Consultation with a licensed funeral director
- ❖ Co-ordination of specified activities, including services and supplies provided by us, as well as those provided by third party suppliers, such as death notices
- ❖ 24 hour availability of funeral director by telephone
- ❖ Includes costs associated with provincial licensing of the business and funeral directors and costs associated with compliance with provincial legislation, including the BAO Consumer Protection Fee (\$30.00 no HST)
- ❖ Completion and filing of all documents necessary to carry out the services and supplies requested, including, but not limited to, death registration, burial permit, coroner's certificate for cremation, documentation necessary to ship the body out of the country
- ❖ Provision of unlimited quantity of Proofs of Death issued by Eternal Care Ltd. (our proofs of death are usually accepted for most estate settlement purposes, but sometimes a provincial "Death Certificate" will be necessary and is available from the Office of the Registrar General)

Initial Transfer of remains \$300.00

- ❖ Initial transfer of deceased from place of death to our holding room (within service area of Lanark, Leeds & Grenville)
- ❖ Additional mileage travelled beyond 50 km from the business outside of the service area will be charged at the rate of \$2.10/km

Transportation remains to/from Crematory/Cemetery \$200.00

Facilities for preparation/shelter \$100.00

- ❖ Facilities used to prepare, and shelter the body
- ❖ Secure shelter as necessary up to 72 hours

Basic preparation of remains (requires Facilities for preparation /shelter) \$100.00

- ❖ The placement of the deceased into the cremation container, including removal of a pacemaker if necessary.

- ❖ **Government and Estate notification;** Full-Service Aftercare which includes a one-on-one virtual consultation with a professional Estate Analyst, Estate Checklist, Estate Guidance, FinalDocx® notifications, CPP Death Benefit and CPP Survivor Applications with Completion Assistance. \$200.00

**Disbursements may vary depending on third party service providers as chosen by the purchaser. Disbursements included in estimation are; coroner's fee, cremation fee, and municipal registration fee, and a . Please refer to page 5 for more information on disbursements.

Note; Estimates *include* the HST that applies to services and supplies.

Disbursements

Disbursements are items arranged for and possibly paid for on your behalf by us. You are expected to pay for these items at the time the contract is entered into. The following are some items that are often identified as disbursements;

Coroner's fee – this is a fee charged by the coroner for issuing a certificate that allows cremation to take place or transfer of remains out of the province. The \$75.00 fee is set by the Chief Coroner for Ontario.

Newspaper notices – this is the charge for death notices placed in newspapers or other media outlets. The cost is based on the newspaper's lineage rate, and is paid to the newspaper.

Municipal death registration fee – this is a fee charged by the local municipality to register the death. The fee is set by the municipality and may vary; the closest current rate is \$30.00

Cemetery Fees – this is a licensed service which cannot be provided by a funeral establishment. Cemetery fees cannot be prepaid with Eternal Care Ltd. At the time of need, however, we would be pleased to disburse the fee for opening and closing of a grave.

Crematorium Fees – Eternal Care Ltd. works with crematoriums in the immediate area, and they vary in price.

Church or Service Hall Rental Fees - The place where the funeral service takes place may charge a rental fee, or be waived in the event the deceased was a member of the establishment. Availability and prices will vary.

Clergy/Musician/Soloist Honorariums - Honorariums may vary between individuals. Typical honorariums fall between \$150-\$300.

Example of Eternal Care Ltd. Disbursements;

- Cremation at Cataraqui Cemetery + BAO consumer protection fee; \$702.35
- Coroner's Fee \$75.00
- Municipal Registration Fee \$30.00

Total Disbursements = \$807.35

Alkaline hydrolysis is available as an alternative cremation choice. Please ask your funeral director for more information regarding process and pricing.

Payment Policy

Pre-arranged Services:

You may pre-arrange your wishes at no charge and your instructions will be maintained on file until the time of need. At that time, a contract is prepared based on rates in effect at the time of your death and which requires approval by your legal representative before any services may be provided. Payment in advance of the provision of services and supplies is an available option with the growth on the invested funds utilized to compensate for inflation.

Trust: You may pay the money directly to us and we will place it in trust, where it will accrue interest until the contract is fulfilled (when the services and supplies are delivered) or the contract is canceled.

At Time of Need:

The legal representative of the deceased must enter into a Funeral Establishment contract. Payment is due at the time our services are rendered by cash or cheque. Should the purchaser not be in a position to satisfy the account at the time the services are rendered, a deposit of a sufficient amount to cover the total of disbursement items, taxes and 10% of the services and supplies will be required. The balance must be paid no later than 30 days from the date of the service. Overdue accounts are subject to interest charges at a rate of 1.5% per month (19.56% per annum) retroactive to the date of the service.

Possession of Cremated Remains and Refundable Deposit:

Eternal Care Ltd. can provide storage of the cremated remains of the recipient at the request of the executor. The cremated remains may be stored for one year from the date of cremation. If the cremated remains are not claimed within one year, Eternal Care Ltd. may inter the cremated remains in a cemetery, including in a common lot for which the cemetery is the interment rights holder.
