WHY DO YOU NEED THAT GUN?

How many of us have ever been asked "Why do you need that gun?" Perhaps it's a spouse, or a family member, or a friend — or an anti-gunner. How do you answer? Here's some food for thought. 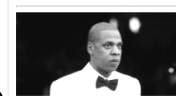

If you have not yet done so, please comment on the Virginia Regulatory Town Hall webpage <http://tinyurl.com/havw4pk>.

This is the comment period for final approval of the Governor's Executive Agency ban on carry. Even if the agency overrides the will of the people, we will need your comments to support a State Agency preemption bill in the 2017 General Assembly session.

Suggested comment title: "I OPPOSE this regulation!"

Suggested comment: "I OPPOSE banning lawfully carried firearms in state agency buildings."

PRESIDENT'S PEN

Who makes up the gun-control community?

After studying the other side for the last 20 or so years, I believe they can be grouped into several broad categories:

* Those with a violent temper, who don't trust themselves. They fear that if they have access to a firearm, they will either murder someone in a fit of anger or commit an impulsive suicide. Because they don't realize they are not normal, they "project" that severe character flaw on everyone else. Therefore, they reason that since they can't be trusted to be a gun owner, no one else can be trusted, either. This category represents the majority of gun-controllers. Because of their visceral self-distrust and associated hatred of guns, they can't really be influenced

* Those who want to control all aspects of everyone else's life. They are mutants who lack the "leave everyone else alone" gene that most of us have. They consider themselves the only ones smart enough to decide what people should or shouldn't be able to do. These are the elitists, the hypocrites, like Rosie O'Donnell, who want armed guards defending themselves and their families, while piously saying no one needs a gun. Since this category cannot be convinced that they are not the brain trust for the universe, they are not really capable of being influenced

* Lazy and extremely insecure people who feel they can only be "safe" if they control everyone and everything around them. They reason that if everyone is disarmed, then they would have no need to take time out of their busy day to think about taking care of their own personal security. Of course, what they want is impossible to achieve. Even if they were somehow successful, the law of the jungle would prevail and they would be at the very bottom of the food chain. This group can be influenced under certain conditions if they are open-minded enough

* Those who have had a horrendous tragedy in their lives involving the misuse of a firearm. These people are trying to cope with unspeakable pain, and are looking for some way to make the death of their loved one into something positive that will prevent other families from suffering as they have suffered. Sadly often those in the above categories will take advantage of such a person's grief to

further their own gun-control agenda. The grieving families become unintentional sock puppets, paraded out at various gun-control events. Some end up enjoying their "celebrity" and make a living by working for gun-control organizations. Except for the celebrities and gun-control employees, their attitudes can often be changed if they can be shown a way to focus their energies in a positive and realistic manner - such as working on improving mental health treatment, intervention to keep young people away from gangs, making firearms training more easily available, etc.

* Those who have been lied to and misled on gun control. This category represents a sizable chunk of the gun-control community and can often be turned around by exposing them to the truth, using logic and reason to repudiate gun control, and teaching them about safely handling firearms and then taking them shooting

Fortunately, gun rights have come a very long way in the last 20 years. That said, things can reverse if gun owners don't stand shoulder-to-shoulder and put up a very strong and relentless fight. That fight is one of the many things VCDL brings to the table. Your membership and activism helps guarantee that VCDL will continue to have a loud and strong voice and I thank all of you for doing your part.

How Voting Scores Are Calculated

Voting scores are calculated using this formula:

- Each vote for a bill VCDL "Strongly Supports" adds 2 to the pro-gun score
- Each vote for a bill VCDL "Supports" adds 1 to the pro-gun score
- Each vote for a bill VCDL "Strongly Opposes" adds 2 to the anti-gun score
- Each vote for a bill VCDL "Opposes" adds 1 to the anti-gun score
- Votes on bills where VCDL is neutral are not counted

Each gun bill introduced is scored as a vote for the patron

Each gun bill introduced on behalf of VCDL is scored as another vote for the patron.

Each bill that is "Pocket Vetoed" and **not** assigned to a committee is scored as an anti-gun vote for the Speaker of the House.

Each bill that is "Pocket Vetoed" and **is** assigned to a committee is scored as an anti-gun vote for both the chair of the committee and the Speaker of the House.

A pro-gun bill modified in a negative manner by the Governor, whose modifications are ruled "non-germane" by the Speaker of the House, is scored as a pro-gun vote for the Speaker.

Scoring example: A legislator introduces a "Strongly Support" bill for VCDL, votes for it in subcommittee, full committee, and on the Floor. His score for that bill would be 10: 2 for introducing a pro-gun bill + 2 for introducing a bill on VCDL's behalf + 2 for the subcommittee vote + 2 for the full committee vote + 2 for the Floor vote.

If two legislators have the same pro-gun percentage, the higher pro-gun score determines which legislator has the better voting record.

Note: Legislators are on certain key committees, such as House Militia, Police, and Public Safety, will have many more votes to score than someone who is not on that committee and can only vote on gun bills when they are on the Floor. In fact some legislators may not get to vote on a bill at all if the bill is pocket vetoed or never reaches either a full committee or the Floor.

The New NRA Basic Pistol Course: An Instructor's Perspective

If you judge it by one simple litmus test — whether it prepares new pistol owners to select and safely handle their firearms — the new (as of 2016) NRA Basic Pistol class is a success.

NRA's Basic Pistol class has been a mainstay for many years, with thousands of students year in and year out. Many NRA instructors, including me, got certified first in this class. The old class was nearly a full day of instructor lead training in the classroom, followed by an hour or so of range time.

The new class, however, changes all of that. Now, the student takes the class in two phases. In Phase I, the student takes much of what was previously taught in the classroom via an NRA training portal on-line. In Phase II, the instructor works with the student through a series of four hands-on, practical exercises to demonstrate comprehension and ability. The first three exercises can be done in a classroom (with appropriate precautions such as no live ammunition allowed in the classroom), while the fourth must be done at a range.

Specifically, Phase I is done at the student's time and pace. The student simply connects to the NRA training site (<https://onlinetraining.nra.org/>) and signs up for Phase I, including paying the \$60 training fee to the NRA. After completing the on-line training, the student then takes a short quiz. A 90% passing grade is required for the student to proceed to Phase II, but the student is given five attempts at passing the exam over a relaxed time period.

Once the student has finished Phase I, she gets a certificate of completion along with a PIN code. She can then go on-line to find a nearby NRA Basic Pistol (Phase II) class and register for it, using the PIN provided at the end of Phase I.

While this might sound unnecessarily complicated, in practice it's really quite simple. NRA says this approach helps ensure students are "pre-qualified" and ready for the demonstrations and exercises with the instructor. Each instructor registers his class on the NRA Instructor portal as normal. Students can then sign up for it as they choose. The result is that only pre-qualified students will sign up for the course.

While some instructors initially complained about the new structure, perhaps under the incorrect assumption that they'd have less quality time with their students, the reverse is actually true. You see, in Phase II, the instructor steps through those exercises with the students. The exercises themselves are highly practical, such as how to load and unload a pistol, align sight picture, and so on.

In other words, the time spent with the instructor is entirely on the practical aspects of shooting. And, of course each instructor is entirely able — encouraged, in fact — to spotlight material taught during Phase I.

To reinforce things even further, the student and instructor fill out and sign off on each exercise step. Take, for example, exercise II, step 1. It says "Student assumed the proper two-handed grip: a) With a semi-automatic, and 2) with a revolver". The student has to actively demonstrate, after the instructor explains,

that she can properly grip a firearm. Only then do the instructor and student sign off on that one step. Each step of each exercise requires a similar sign-off by both instructor and student. A copy of the exercise checklist is retained by both instructor and student as well.

The exercises themselves range from fundamentals such as establishing the student's dominant eye to loading, unloading, de-cocking, and so on. They are all practical and useful skills to be able to perform, and requiring the student to learn and demonstrate each and every one results in students that are highly prepared to safely go out and select a firearm and then use it safely.

The big advantage of this new "blended" approach is that the students study the most fundamental terms and such first, and then the instructor verifies what they've learned and retained through these practical, hands-on exercises. Thus, there's more time to focus on the things that matter most, without having to spend as much time on basic terminology, definitions, and such.

So, at least from this instructor's perspective, the new courseware is more effective at delivering students who have a deeper and more practical understanding of the basic functions of a modern pistol. When they've finished the course, they should have all of the knowledge, skills, and attitude to head out and select the right pistol for their needs, and to be able to operate it safely from day one. And, of course, the students still get an NRA certificate of completion, and their accomplishment is recorded on the NRA training portal.

I call that a victory.

For my Dad, it was golf. He was crazy about it. He bought good clubs, balls and other paraphernalia. He loved to travel and play world-class golf courses and had the help of his local PGA pro to get him "privileges." One of his favorites was Pebble Beach, with which I'm sure golfers - or Californians - are familiar. The "greens fees" (price of an 18-hole round) over there is \$495 (plus the cost of getting there). And... I'm sure there's a waiting list to play. How does that differ from playing a weekday round at the local cow-pasture? For me, it doesn't. I'd be equally bored in both places. Pebble Beach Golf Course is gorgeous, but I can enjoy the view of the Big Sur without pushing around a little white pill.

One more point. When my Dad played Pebble Beach, or Augusta or St. Andrews in Scotland, he had nothing to show for it except a memory and the day's enjoyment. That was enough for him and, since it was *his* money, who's to say it was wrong? Jay Leno and I end up with a salable asset (except ammo) which allows me some rationale for my purchase. When I get the gun, I'll (hopefully) enjoy it and when I tire of it (or die), it will fetch a decent price, either at the gun shop or Internet auction. I'm not saying that I'll get all my investment back or make a profit (although Jay Leno will). I just don't look at the purchase as "money lost."

I'm (slowly) trying to make a point. When others challenge what you legally do, there is the implicit comment that they have some right to judge or prohibit. This then reveals the notion of many people these days, that they do have the right to challenge another person's wealth, expenditures or legal behavior. With that statement they, in effect say... your money really belongs to US and we're pissed that you're wasting it on your selfish self.

I know, I've turned a simple gun-question into a political/economic statement or even an existential one. But, that's how I roll.
