## MEMBER RECRUITMENT CONTEST

With the current make up of the Legislative and Executive branches of government in Virginia, VCDL needs to be stronger and more active than ever. Since we both need and want new members, let's make it interesting! The VCDL Board of Directors has approved a membership contest for 2018.

To encourage you to speak to others and recruit them to membership, the contest will run to the end of 2018.

Winners will be announced at Lobby Day, January 21, 2019. Remember, too, memberships purchased between now and 1 October are good until **next year** — 30 September **2019**.



Simply write your VCDL membership number on the application before handing the brochure to a new prospective member. When that person mails in the brochure page with payment, you will get credit. This contest is for **new** members only—not renewals.

The person with the most credits as of December 31, 2018 will get a choice of either a rifle, shotgun, or one of three handguns! The person in second place will get the next choice out of the remaining firearms, and so on, until the top 5 individuals have received a firearm. Ammunition or other prizes will be given to those who place in positions 6 through 10. As of press time, the person in first place has 11 recruits, with 9 and 7 following. That leaves a lot of room for others in the next six months!

Working VCDL's booth at gun shows and other events is a good way to increase your recruitment numbers. Signing up friends, family, coworkers, or handing out brochures at non-VCDL events is another way. Ensure you have a brochure or three with you when you head out for the range!


**If you have an old brochure.** Some old application forms still exist. Simply annotate "Recruiter Member # 104414" so the

## PRESIDENT'S PEN

### MARCHING TO TAKE AWAY CIVIL RIGHTS?

The preamble to the Declaration of Independence starts out, "We hold these truths to be self-evident, that **all men are created equal...**"

And the struggle for the civil rights for ALL Americans was largely successful.

But things have changed. Down is now up and up is now down. The First, Fourth, and Fifth Amendments are all under attack. But the Second Amendment is, by far, the one in the crosshairs.

In this alternate universe where we find ourselves living, some people are actually marching to take away one of their (and our) key civil rights. The civil right that says citizens can defend themselves and their family from criminals and even from their own government if it's gone rogue.

Who in their right mind would march **against** a civil right?

Part of the problem is ignorance. Our schools are busy indoctrinating students into the world of political correctness, not teaching them civics or about the evolution of our liberties in this great country. Responsibility? Forget about it. Schools drill children to be frightened of guns. Bite a Pop Tart into the shape of a gun and you are the one who is toast. Draw a gun on paper and you're gone. Wear a hat inscribed with nothing but the words "Smith & Wesson" and you're expelled. Kids who are earnestly marching for gun control have purposely not been taught about the fate of those in the past who were disarmed by their governments.

## WHAT WE COULD LOSE

Those of you who know me know that I originally come from England, and I can talk first-hand about gun control. It saddens me when I hear of club members and other shooters speaking out against particular firearms or disciplines thinking it won't affect them. I know from experience they are wrong; I've seen what happens. In 1988, all semi-automatic and pump-action rifles were outlawed (with the exception of .22 rimfire) following a mass shooting in the town of Hungerford in England. Rather than trying to fight the legislation, other shooters spoke out against those types of firearms thinking it would not affect them. Then, in 1996, all handguns were outlawed following a school shooting in Dunblane, Scotland. Again, very few shooters spoke out against that legislation. I personally had to surrender several handguns and received a very meager amount of compensation. Legislation has now progressed to the point that air rifles and BB guns are becoming heavily restricted. In addition, non-lethal self-defense tools, such as pepper spray, are prohibited. Now is the time we need to pull together and support each other. If we don't we have a good chance of losing a lot more than we bargained for.

I also get tired of hearing people say that nobody needs an AR-15. You could say the same about fire extinguishers. Nobody plans to set their home on fire so why would they need one? Because unexpected things happen. Let me paint you a picture. Imagine you are living in a city with your family when a severe weather event happens, such as a tornado. You have young children, maybe a teenage daughter. You hear reports on the news that the city is suffering power outages, then your power goes out. Some people are able to leave and stay with friends or relatives, others are not so lucky. Imagine you are part of the latter group. Now, imagine that it's going to take several days to a week before power gets restored, just like during the 2012 derecho.

Now, picture yourself sitting at home, it is starting to get dark. You hear loud noises from across the street followed by a woman screaming. You look out of your window and see a gang of 7-8 thugs breaking into your neighbor's house. You take out your cellphone to call 911, but there is no service as the local cell towers were damaged during the weather event. The gang exits your neighbor's house and starts heading your way. Now let me ask you, do you really need that AR-15 with a 30-round magazine?

Now is the time to draw a line in the sand. Contact your representatives and tell them that you are against further gun control. Educate friends and relatives about guns; practice good gun safety habits and let people know you are a responsible gun owner; donate to gun rights organizations (NRA, VCDL, GOA, etc.) that are fighting for your rights; and most importantly, if you have kids, teach them gun safety, and also teach them to look out for other kids, especially those who are being bullied. Teen suicides are reaching record highs, and each one of those has the potential to be the next school

shooter. Maybe if we can focus on helping each other rather than on blaming inanimate objects we can start to make a real difference.

## GUN CONTROL IN THE US

If you are ever wondering what some folks have to go through in states that don't have the same liberties as a place like Virginia, I can surely let you know a thing or two.

I moved to VA in the spring of 2016. I grew up in New Jersey and then went to college at Virginia Tech. After graduation I lived one short year in Michigan and travelling the road for work. Finally, I settled in Northern Virginia in spring 2016.

I've called this home since I became a Virginia resident in fall 2016. Since then, I bought my own first handgun in May 2017 (now I own 4 and 1 rifle), I've become an NRA member and VCDL member, I've been to a number of gun shows, I've taken friends shooting for their first time.

Things weren't always this smooth when it came to my ownership of guns. I've always been fascinated with firearms, and that's a tough itch to scratch when you are from a place like NJ.

My father owned a number of firearms; he taught me and my siblings about safety. We had opportunities to shoot when we visited family in North Carolina, at an indoor range not far from home, and those few times we practiced rifle in the Boy Scouts.

New Jersey, as I'm sure you are aware, has some very tough restrictions on firearm ownership. I'm not sure of the entire legislative history, but I can let you know where it's at since I dealt with it first in 2011.

At 18 in NJ, you cannot just buy rifles and shotguns as in most states. You must first apply for and receive a Firearms Purchaser Identification Card. For this you must complete an application form, be fingerprinted, and fill out a Consent to Mental Health Records form. All of these must be submitted through your local police department.

So shortly after my 18th birthday in 2011 I went to submit these forms to my local PD. Let's just say they were less than happy about it. I grew up in this town of about 5000 residents my whole life. I lived at the same house, met police through school programs, Cub/Boy Scouts, DARE, and I was never in trouble (unless you count the time they scolded us for playing paintball in the woods).

NJ Police do not want you to fill out these forms. They don't want you to be another gun owner.

They informed me I would need to come back once I went to a facility to get fingerprinted (at my expense) and submitted

those fingerprints to the PD. These fingerprints are sent to the FBI. I had to schedule an appointment for that fingerprinting, which was months away because of their low availability. Also, I would be off to college in August. In November I was fingerprinted and submitted this to the PD.

Then started the waiting game. Months went by and no answer. You have to list two non-family references on the form, and neither of them had been contacted. I called the PD a couple of times to check in and they would brush off the call with no updates.

Finally I got confirmation. In May 2012. What had been listed as a permit that only takes 30 days to issue took me 9 months.

After everything was confirmed, I had to go to the local PD to get the card. I can still recall the hostility of the PD when they went to double take my fingerprints and apply one to the back of the card (which is accompanied by all my other information and a signature from the Chief of Police).

I had completed my whole first year of college in the time it took to get this permit.

Now for the next couple years, I attended Virginia Tech but kept my NJ license and residency. This permit was so I could transport my father's guns that he had lent me down to VA so I could shoot at local ranges.

To make another long story short, I had to submit some of the exact same forms in order to purchase a handgun in VA. Yes, one application per handgun. When I went to do this, I thought it was smooth sailing since I had the NJ Firearms ID and I hadn't been in a lick of legal trouble since I first got it.

A couple months later I got a letter stating I was denied the handgun permit. When I called the PD they said it was due to information on my handgun application being different from my original application for the ID. They would not tell me what that information was, and there is no re-application method. To amend any of this requires an appeal -with a lawyer - and this gets into the range of thousands of dollars in legal costs.

I felt betrayed. I had done nothing wrong and yet I was denied my right to simply buy a handgun. I lost total faith in the legal system of my once home state.

It has been a couple years since I read that letter, and since then I have passed numerous background checks for my purchases and I'm also a concealed handgun permit owner in Virginia.

Paperwork slip ups and sluggish processes should not stop law-abiding people from owning a means to defend themselves.

I tell this story because I saw firsthand what "common

sense" gun control looks like. It feels terrible to be treated like a criminal or a threat when you have done nothing wrong. I never want to see that system in Virginia, or any other state for that matter.

My story is probably not unique, and I'm sure folks have had it much worse at the hands of unfair legislation. But I think it's important to share it with people who have had relatively smooth sailing when it comes to how they have exercised their 2nd Amendment rights.

**In Virginia, 'militia' means teens, too**

Editor, Times-Dispatch:

In a thoughtful letter from a Richmond-area high school government teacher, "Civics classes still teach the Constitution," she notes that some of her students wonder if the Second Amendment's reference to a "well regulated militia" includes "teenagers purchasing weapons designed for war."

I modestly suggest that she and other government and civics teachers in our commonwealth add the following to their resource references and bring it to the attention of students: The "militia" in Virginia is clearly defined by law in Section 44-1:

"The militia of the Commonwealth of Virginia shall consist of all able-bodied residents of the Commonwealth who are citizens of the United States and all other able-bodied persons resident in the Commonwealth who have declared their intention to become citizens of the United States, who are at least 16 years of age and, except as hereinafter provided, not more than 55 years of age. The militia shall be divided into three classes: the National Guard, which includes the Army National Guard and the Air National Guard; the Virginia Defense Force; and the unorganized militia."

Accordingly, most everyone from teens to pre-geezers is subject by law to be called into militia service by the commonwealth in event of an emergency.

One might even suggest that due diligence compels us to be prepared to bring along a personally owned AR-15 (a civilian -legal counterpart to current U.S. military M-16 and M-4 rifles) and be suitably skilled in its use.

"Thoughtful discussion" is likely to follow.

## A SUCCESSFUL CONVERSATION

I'm in the process of building a new home and I've been visiting different vendors. One of the vendors is Ferguson Bath & Kitchen at 2703 Ackley Avenue in Henrico, VA. I bristled with each visit because they have an anti-gun sticker on the front door (gun with circle/slash).

I decided to email their corporate office today to express my view and seek out a point of contact. Within about 45 minutes, I received a voice mail from Ray Ferrara, Director of Security for all of Ferguson, based out of the Newport News area.

Best conversation I've ever had in one of these situations.

Ray is a patriot. Former VA State Trooper & Marine. We talked firearms and family for about 30 minutes. In short, he said he was unaware of the sign and he had already called the store to tell them to remove it. He said if it's not down by next week, to let him know and he would come here to personally remove it. I promised I would check it out next week to confirm.

He said he's not afraid of open carry or concealed carry...only criminal carry. He said the sign should and will come down. Their corporate position is not anti-gun. He shared that years ago someone was open carrying a gun in one of their stores, dropped the gun and it went off. In response, the former head of security told all the stores to adopt a "no guns" policy. Ray has been working to reverse that policy and they are removing any legacy signs that remain.

Great conversation and Ray was professional, polite, and I could not have asked for a better call. Fun conversation and a win for taking down an anti-gun sign.

## GENERAL ASSEMBLY VOTING RECORDS NOW ONLINE

VCDL's 2018 General Assembly Voting Record is now on the VCDL web site! This annual report lets you see how your Delegate and Senator performed in supporting your right to keep and bear arms.

There are two listings for the House and two for the Senate—one in alphabetical order by name and the other sorted by pro-rights voting score, from best to worst.

The winners this year were:

### SENATE

1st place: Senator Carrico; 2nd: Senator Dunnivant; 3rd (tie): Senators Newman, Ruff, Vogel, and Wagner

### HOUSE

1st place: Delegate Webert; 2nd (tie): Delegates Freitas and Wright; 3rd (tie): Delegates Head and Rush

### SCORING NOTES

\* Votes are graded using a point system: 1 point for voting for a bill that VCDL supports, 2 points for a strongly supports, -1 point for oppose, and -2 points for a strongly oppose.

\* Besides his actual votes on the House Floor, the Speaker gets positive points for any anti-rights bills that don't make it to the House Floor for an up-or-down vote and for any pro-rights bills that do. He gets negative points for any pro-rights bills that don't make it to the House Floor for an up-or-down vote and for any anti-rights bills that do.

\* Besides their actual votes, committee chairs get positive points for any anti-rights bills that are pocket vetoed and negative points for any pro-rights bills that are pocket vetoed.

\* The number of votes cast are taken into account. Someone who has voted perfectly with 64 points will be in front of someone who also voted perfectly, but only had 60 points. For example, if it weren't for one bad vote, Delegate Fariss would have been in 1st place. Because there were 32 100%- scores in the House, Delegate Fariss ended up 33rd from the top with a 98% score! Delegate Cline also had only one bad vote, but with far fewer chances to vote than Fariss, he came in 34th from the top with a 91% score. A similar situation existed in the Senate, where Senator Obenshain could have easily been in 1st place, but for one bad vote that gave him a 96% score, putting him in position 12 from the top.

Delegate Webert had the same exact voting record as both Delegates Freitas and Wright, but took first place by one point because he introduced a pro-rights bill that VCDL "supported," while Freitas and Wright did not.

\* Republicans dominated the pro-rights votes. The highest score for a Democrat in the Senate was Senator Lewis with a 33% score, making him 22nd from the top. In the House, the best Democrat score was Delegate Filler-Corn with 33%, making her 46th from the top.

\* This was an unusual year as many legislators only got to vote on one or two bills that made it to the Floor. Hence you will see some surprising zero scores when a legislator had one chance to vote correctly on a gun bill and blew it.

\* Detailed information on how the scores are calculated, as well as the actual scoring of each legislator's vote, is included in the voting record document.

**CHP RENEWALS**

Virginia law provides that you can get the full five years of your Concealed Handgun Permit if you apply for renewal at least 90, but no more than 180, days prior to expiration of your current permit. (Section 18.2-308.010)
