What to Expect at Lobby Day 2023

You have guestions. Here are some answers. by Patricia Webb, Secretary/Treasurer

Every year we get a lot of questions about Lobby Day. Some are the same year-to-year, other answers are specific to each year. I'll try to answer many of them here.

Q: Will there be a rally this year?

A: Yes, we will be holding a rally at the Bell Tower in Capitol Square. I'm hearing good things about guest speakers and wager you won't want to miss this!

Q: Lobby Day is on a holiday. Will the General Assembly be in session?

A: Yes, we selected MLK Day for many reasons. First, the General Assembly is just starting the new session, and they don't take the day off. Second, many people have the day off work and are able to attend when they otherwise wouldn't be able to.

Q: Can you have this at a warmer time of year?

A: I suppose we could, but we base the date on the General Assembly session, which begins in early January and is over long before the warm weather. So to be effective, we must brave the cold.

Q: Can I carry? Why doesn't Governor Youngkin reverse the **Executive Orders?**

A: Sadly, the EOs were replaced with laws banning firearms in Capitol Square and all state government offices. They did this to discourage us from showing up for Lobby Day. This shows just how effective our presence is. We can't let not being able to carry at the General Assembly stop us from being heard. We're working hard to get that dangerous law repealed, but until then we can't carry at Lobby

Day. We need your help to repeal these dangerous laws. The first step is showing up for Lobby Day. The next step is watching for the bills to get to committee and sending in the emails and making phone calls!

Q: What bills are we lobbying for?

A: As of this writing, the bills are still dropping. But before Lobby Day gets here, VCDL compiles a list of all the 2A bills, whether we support or oppose them, and why. Each team will be supplied with these to hand out to the offices they visit. You will be able to follow all the bills on our Legislative Tracker, which will be up on the website by then.

Q: Will there be buses?

A: We've put out a survey to gauge the interest in buses. As the cost rises, we must evaluate if there are enough riders to warrant the tens of thousands of dollars it costs to bring buses from around the state. However, we do have a carpool website set up for those who want to ride share. Check it out at VCDL.org/LobbyDayCarpool and watch the VA-Alert for more information on transportation.

Q: Where can I park?

A: Because it is a holiday, you don't have to feed the parking meters if you park on the street. There are several parking lots near Capitol Square, as well as parking garages. Be aware that the law bans firearms in state parking garages. You can find a list of parking by using your search engine and looking for "Parking near the VA General Assembly."

A reader wrote a detailed letter calling us to task on our quotation from Thomas Jefferson last issue. The quote (which appeared on page 6 as filler) is apparently from Cesare Beccaria, an Italian philosopher who profoundly influenced the Founding Fathers. Jefferson copied this passage into his Commonplace Book, which is how most of us know it.

Great men crib great ideas all the time. One point the reader made bears repeating: "I do not think such a...comment needs to come from Mr. Jefferson for its power; an appeal to authority is not needed." Appeal to Authority is a logical fallacy where one assumes an argument has more weight because of who said it, even if that person has no expertise on the relevant topic

This is not the case here. That Jefferson copied and noted the point is crucial to understanding the Second Amendment and the architecture of our society. We look to the Founding Fathers' writings to battle false notions about our Constitution. Beccaria may have originated the idea, but Jefferson and his ilk laid it at the foundation of the United States. I don't feel bad appealing to Jefferson's authority rather than Beccaria's or Taylor Swift's. Not at all.

Rest in Peace Ed Levine, Mike Wilburt, Frank Stanisz, and Dave Kopp

In one month, VCDL lost Ed Levine, a Board of Directors member/Social Media Coordinator, and two gun-show coordinators, Mike Wilburt and Frank Stanisz. Our sister organization, the Arizona Citizens Defense League (AZCDL), lost their president, Dave Kopp, in September.

Ed Levine

VCDL Board member Ed Levine died unexpectedly in early November at the age of 60 from what appeared to be a major heart-attack. No one on the Board had a chance to prepare for, or brace themselves for, that loss.

I had known Ed for well over a decade. From the beginning, even as a regular member, Ed was a strong supporter of VCDL and our mission. He was consistently coming up with ways for VCDL to make money to further our cause and ways to promote who we are and what we do. And, of course, he was a regular at working gun shows. Beside guns, Ed loved riding motorcycles, flying airplanes, and, above all, his family.

Seeing Ed's actions and future potential, Ed was voted in as an Executive Member by the VCDL Board of Directors in 2010. Later, his fellow Executive Members voted Ed onto the VCDL Board of Directors, where he had served for several years, up to his death.

Ed played a crucial role in organizing and coordinating VCDL's presence on social media. He formed a team of administrators in order to keep our online presence active and the information there up to date. Ed made sure that VCDL is on pretty much every social-media platform out there. Thanks to Ed we are not beholden to one or two platforms that could block us at will.

Ed arranged for VCDL to have monthly membership meetings at XCal in Loudoun County and set up our monthly virtual membership meetings, with live feeds to YouTube and Facebook.

Ed was popular and was widely admired and liked. I'd love to see his entire selfie photo library. I swear he knew or met anyone who was anyone in the gun world or elsewhere. VCDL often got to take advantage of Ed's many connections.

No funeral arrangements have been made for Ed as of the time this is being written. All I can say is that it better be a really big venue to hold all of his friends and acquaintances.

Mike Wilburt

When VCDL needed a gun show coordinator for the Richmond area years ago, Mike Wilburt stepped up to the plate. Having a strong background in retail marketing, including in purchasing for Circuit City, Mike organized the VCDL table meticulously, with all items professionally labeled.

When Mike started having some critical health issues, he told me he would have to step down as he could no longer do all the standing and setting up/tearing down the table, that was required of a gun show coordinator. VCDL needed someone to coordinate all the various gun shows at an administrative level. That position was offered to Mike, who accepted. He could do everything at home using a telephone and a computer. Mike did a great job keeping all of our gun shows running smoothly.

While he was seriously ill, he died unexpectedly, but peacefully, at home in October. He was laid to rest on October 25.

From the Secretary's Desk There is No Finish Line

Hollywood and (Firearm) Reality

Consider a staple scene shown countless times. The good guys are about to enter some building. The camera angle shifts to inside the building. Doesn't matter if the door is opened gently or kicked open—the first to enter leaps into the center of the doorway and pauses dramatically to assess the situation while being silhouetted in the door frame. Pretty much an invitation to get shot! The same thing is seen at corners of buildings or hallways. Some variation of it while going up/down stairwells.



Then there's the handgun always in the firing position with outstretched arms. There are numerous issues with this. The extended arms/gun can flag your position (give it away) to others while moving. The hands/arms/gun also blocks a lot of your field of vision. You can check in a mirror how much your hands/unloaded gun block of a threat. Threats may lurk unseen waiting until you're within reach and it's extremely easy for someone to rip the gun out of your hands in that extended position. There are ready positions (gun at center of chest, muzzle forward and 45 degrees up or center of body at waist level, muzzle forward and 45 degrees down for instance) that offer better advantages. Your field of vision has no obstacles, your head is free to search and your response to a threat is either the same or faster than the Hollywood version. When justifiably holding someone at gunpoint, one always wants to see their hands.



Then there's the cinematic head shot in the center of the forehead. The medical community labels this the cranial vault because the

skull is a surprisingly durable body part. Head shots are a firmly established tradition—a way to show the hero's prowess and provide a spectacle of exploding brains and skull fragments. In real life, the head is a target of last resort with a handgun and the forehead isn't the target area in the real world.

With the above in mind, let's look at some things you should consider while practicing. There is a data base of real world

private citizen defensive shootings. The average range is 5 yards and 3 shots usually solves the problem of a single attacker. But you can't count on that. The extremes in ranges are two yards and 27 yards. Your goal should be the ability to deliver accurate (paper plate-size groups at your point of aim—if your range allows silhouette targets, the top of the paper plate should be at the neck/body line), deliberate, aimed fire at a round per second cadence at the closer ranges. Down there at the 2 and 5 yard

line, you want to be doing much better. As your skill improves go to smaller targets. At 27 yards your best real world first action is likely to be getting behind something that stops bullets (cover). At the end of each string of fire and before you holster or quit, you should do a global 360 degree, plus overhead and ground level scan. This is building a habit pattern to check for previously unrecognized threats. Feel free to move your feet while doing so while keeping the firearm pointed in a safe direction.

There's also a presentation in the latest Force Science Institute free newsletter on the need to move so you don't present a stationary target: Firearms Training for Real World Assaults (www.forcescience.com/2022/02).

They strongly suggest that you practice moving while getting your gun out and into operation. Possibly including shooting while moving, if possible, at the range. Lateral (side to side) movement is generally less of a problem.



I expect that some may disagree with some of my comments, particularly about using a ready position when searching. I have limited space here, and there are legitimate differences of both training doctrine and opinion in this area. I'll point out that what works for a military unit or tactical team where they do everything as part of an integrated team is a wholly different situation than a private citizen by themselves. Each team member has a particular slice of the surroundings as their own personal responsibility. Also, they've often got exotic stuff like night vision gear and they can see the adversaries before the adversaries know they're around. They may also be wearing gear that allows communication, enhanced hearing and protection against gunshot damage to hearing. The ear protection is available at reasonable prices (Peltor Tactical Pro, MT15H7F SV) and highly advisable-even if it doesn't have multi-channel com gear.

To borrow a quote from famed firearms trainer Clint Smith : Don't die stupid. And be safe.

O: How should I dress?

A: Business casual or nicer.

Q: Can I bring my kids?

A: Yes! This can be an educational moment for them, especially if they are school age.

Q: I've never lobbied before, how will I know what to say?

A: First and foremost, speak from the heart. You will be paired with experienced Lobby Day veterans. You don't have to speak if you don't feel comfortable doing so, but just by being there you are having an impact. If you do choose to speak on a bill that you care passionately about, speak from experience. Make it personal. Showing how something impacts real people carries more weight than anything. Be polite and respectful but let your passion shine through.

Q: Where do I find my team?

A: Team Leads will be gathering team members at the corner of 9th and Main Streets in Richmond. This is right next to the Pocahontas Building, the temporary home of the General Assembly.

Q: Will I be on a team that is assigned to my Senator and Delegate?

A: Chances are, no. But don't let that stop you from making an appointment with them! In fact, when I've led teams in the past, after we visited our assigned offices, we went as a team to the representatives for each team member.

And don't forget to sign the guest book! They do look at that. Make sure to mark that you are a constituent and a member of VCDL.

Q: I'm coming from far away. Are there places where I can stay Sunday night?

A: Yes! There are a lot of places to stay, both in Richmond and in the outlying areas. Again, your search engine is your friend.

Q: Will there be a Lobby Day Dinner this year?

A: Yes! We will be announcing the venue in a future VA-Alert, but we will have a dinner the night before for those who are coming in from out of town to enjoy some fellowship.

I hope that these tidbits help you, and more than that, I hope that we see you at Lobby Day. This is our Superbowl. Our Prom. This is YOUR chance for face time with your Senator and Delegate. This is your chance to help turn Virginia back into a free state, but only if people care enough to show up. The Anti's are hoping that they can deter us by banning carry. They want us to just go away and give up. Its for sure that our opponents never give up, so we can't either. Not attending Lobby Day sends a message that they won. We can't let that message go out! So grab your family, friends and neighbors, stuff them in the car, and get yourself to Richmond.

The VCDL-PAC has had a busy summer and fall, especially for a midterm year. While we are a state PAC and can't endorse in the federal elections, we did endorse many candidates for local races. We were hoping to see gun owners show up in droves to vote for their gun rights, but the turnout was just slightly more than average. We did see a record number of mailed in ballots for a midterm election.

The VCDL-PAC held their second Annual Top Gun Fundraiser and Shooting Competition and raised several thousand dollars. But we will need a great deal more heading into 2023. Next November the entire General Assembly is up for grabs. This could be the make-or-break moment, not jut for Virginia gun owners, but for the entire country. Trends start here, so we need to get busy now positioning for the 2023 elections.

This is an exciting time to be involved with 2A rights. The recent *Bruen* decision has opened many doors, but will also spur those who would negate our rights to push even harder. So we must keep the momentum going. Part of that is getting people in office who will repeal the gun control passed in 2020. We need your help, both financially and in campaigning for worthy candidates. Yes, times are hard, but if you can spare just a few dollars a month it goes a long way when combined with other contributions.

The VCDL-PAC has no membership dues. It relies totally on contributions from generous donors like you. We thank you for your support, and we will work hard to elect people who will protect your rights.

CHP RENEWALS

Virginia law provides that you can get the full five years of your Concealed Handgun Permit if you apply for renewal at least 90, but no more than 180, days prior to expiration of your current permit (Section 18.2-308.010). Members can add their permit expiration date to their member profile for email reminders during the 90–180 day window.
