

Sunshine Paddle Tours – Tour Policies

These Tour Policies apply to all experiences operated by **Sunshine Kayak Tours LLC, DBA Sunshine Paddle Tours** (the “Provider”).

Important Information

Tour policies may vary by location due to local regulations and site-specific requirements. The policies in effect at the time of booking apply to the selected tour and location.

Children & Minors

- Children 6 years of age and under must wear a properly fitted U.S. Coast Guard–approved life jacket at all times.
 - Participants over the age of 6 may be required to wear a life jacket when required by law or when instructed by the Provider.
 - Minimum age requirements may vary by tour and location based on safety considerations and local regulations.
 - Participants under 18 years of age must have a parent or legal guardian complete and accept the required waiver on their behalf.

Alcohol & Substance Use

- Alcohol and illegal substances are strictly prohibited on all tours operated by the Provider.
 - Participants who appear impaired or fail to comply with this policy may be denied participation or removed from the tour.
 - No refunds will be issued for removal due to a violation of this policy.

Health & Medical Considerations

For safety reasons, all participants must be physically capable of participating in a guided kayaking or paddleboarding experience.

Guests should not participate if they have medical conditions that may be aggravated by physical activity or water-based environments, including but not limited to:

- Heart or cardiovascular conditions
- Severe back, neck, or spinal issues
- Recent surgery or injury
- Respiratory conditions triggered by exertion
- Conditions causing dizziness, fainting, or loss of consciousness
- Pregnancy without prior medical clearance

Additional information:

- Guests are responsible for assessing their own physical condition and limitations prior to participation.
- Guests with medical concerns are encouraged to consult a healthcare professional before booking.
- Guides are not medical professionals and cannot assess individual fitness levels.
- The Provider reserves the right to deny participation if a guest's condition appears to pose a safety risk.

Cancellation Policy

- Reservations may be cancelled or rescheduled up to 48 hours before the scheduled tour start time for a full refund.
- Cancellations made within 48 hours of the scheduled tour start time are non-refundable, unless Trip Protection has been purchased.

Trip Protection

- Trip Protection may be purchased at the time of booking for \$10 per person.
- Trip Protection cannot be added after booking.
- With Trip Protection, guests may cancel their reservation between 48 and 24 hours before the scheduled tour start time and receive a full refund.

Non-Refundable Situations

The following situations are non-refundable, even if Trip Protection was purchased:

- Cancellations made within 24 hours of the scheduled tour start time

- No-shows
- Arriving with fewer participants than originally booked, including individual no-shows within a group

In these cases, the full tour price will be charged, and no refunds will be issued for missing participants.

Cancellations & Changes

- All cancellation or rescheduling requests must be submitted through the booking system or via the contact details provided in the booking confirmation.
 - Refund eligibility is determined by the time the cancellation request is received, not by the scheduled tour start time.

Arrival & Check-In

- Guests are asked to arrive at least 15-20 minutes prior to their scheduled tour or pick-up time.
 - Late arrivals may result in an inability to participate, depending on tour logistics and safety considerations.
 - All participants must complete the required waiver prior to the start of the tour.

Text Messaging (SMS)

By providing a mobile phone number during booking, guests consent to receive essential tour-related text messages, which may include:

- Booking confirmations
- Tour reminders
- Important updates regarding the scheduled experience

Additional information:

- Message frequency is limited and focused on the booked tour.
 - Message and data rates may apply.
 - Mobile carriers are not responsible for delayed or undelivered messages.
