MINUTES SPECIAL CALLED MEETING OF MAYOR AND COUNCIL FEBRUARY 19, 2024, 12:00 p.m.

The Town of Pine Level held a Mayor and Council Special Called Council Meeting on Monday, February 19, 2024, in a meeting room of the Pine Level Volunteer Fire Department.

PLEDGE OF ALLIGANCE

INVOCATION Councilmember Bixler gave the invocation.

<u>CALL TO ORDER</u> Mayor Bigley called the meeting to order.

<u>ROLL CALL</u> Mayor Bigley called roll. Present were Councilmembers Bixler, Hickman, Moore and Worcester. Also, present was Town Clerk Theresa L. Cook and Town Attorney Nancy Kirby.

Mayor Bigley presented an overview of the election process of the council seat vacancy. He then called for nominations.

Councilmember Hickman nominated William "Jae" Gray. Councilmember Worcester seconded this nomination.

Councilmember Bixler nominated Jason Mayhan. Councilmember Moore seconded this nomination.

Being no other nominations, Mayor Bigley closed the nominations closed and called for a roll call vote of nominee William "Jae" Gray.

Mayor Bigley asked Town Clerk Theresa L. Cook to notify the two candidates.

Mayor Bigley presented information on the Town's logo being designed by the Marbury High School Art Class.

Mayor Bigley presented the need for the Town to have a post office box in Prattville for town mail. Mayor Bigley made a motion to open a post office box and it was seconded by Councilmember Moore. It passed with a unanimous vote.

Mayor Bigley announced that he, Town Clerk Cook and Councilmember Bixler have a meeting with Central Alabama Regional Planning & Development Commission. While there, they will be discussing the car show being scheduled for April 13, 2024. Councilmember Bixler made a motion to proceed with plans and Councilmember Moore seconded the motion. It passed with a unanimous vote.

Mayor Bigley announced that Spirit Walk Ministries has an area for the Town's use as for an office. Mayor Bigley made a motion to proceed with these plans and Councilmember Moore seconded this morning. It passed with a unanimous vote.

Mayor Bigley announced a Groundbreaking Ceremony for the Pine Level Park and encouraged everyone to attend.

Councilmember Moore suggested that the Town look into town limit signs. Councilmember Worcester said that Autauga County Commission could help.
