4. **Arrival Time:** Gates open to vendors Saturday morning 6:00 am to 8:00 am.
Do not arrive before 6:00am - gates are locked and vehicles are prohibited from parking on Route 216.
5. It is beyond our control to keep out "early bird shoppers." Please allow yourself enough time to be in your space by 8:00 am.
6. The sale is held **RAIN OR SHINE**.
7. Booths are to remain open until 3:00 pm.
8. Hours of the sale to the public are 9:00am to 3:00pm.
9. The sale will be outdoors and is located at **Stormville Airport, 428 Rt. 216, Stormville, NY.**
10. **NO PETS ALLOWED.**
11. Items for sale must be "used" such as clothing, household items, furniture, toys, books, sporting goods, etc. Please make sure all items are in working condition as there is no electric available.
