IF A MORE ADVANTAGEOUS TRANSACTION IS NOT REASONABLY POSSIBLE THE BOARD OF DIRECTORS SHALL DETERMINE BY MAJORITY VOTE OF THE DISINTERESTED DIRECTORS WHETHER TO ENTER INTO THE TRANSACTION. IF THE BOARD OF DIRECTORS HAS REASONABLE CAUSE TO BELIEVE AN INTEREST PERSON HAS FAILED TO DISCLOSE ACTUAL OR POSSIBLE CONFLICTS OF INTEREST, IT SHALL INFORM SUCH PERSON OF THE BASIS FOR SUCH BELIEF AND AFFORD HIM OR HER AN OPPORTUNITY TO EXPLAIN THE ALLEGED FAILURE TO DISCLOSE. PERSONS WITH A CONFLICT SHALL BE EXCUSED FROM THE MEETING OF THE BOARD OF DIRECTORS CALLED TO DETERMINE WHETHER A CONFLICT EXISTS. IF, AFTER HEARING THE PERSON'S RESPONSE AND MAKING FURTHER INVESTIGATION AS WARRANTED BY THE CIRCUMSTANCES, THE BOARD DETERMINES SUCH PERSON HAS FAILED TO DISCLOSE A CONFLICT OF INTEREST, IT SHALL TAKE APPROPRIATE DISCIPLINARY OR CORRECTIVE ACTION.
