This form is not a substitute for the lease. When you arrive at our office with the completed form, you should be prepared to follow all leasing procedures!

Before coming to sign a lease, email our office and request a digital application, we will need your full name, your email, and the unit that you're hoping to rent. If you have roommates, there is a 'copy' link on your application to send them so that all roommates are grouped together.

At least one resident from your lease group should come to our office prepared to do the lease. ALL LESSEES must be prepared to activate their portal, pay their first month's rent with \$20 Digital Convenience Fee, and sign the lease AT THAT TIME, whether they're in the office or not.

Once the portals are activated and first month's rent is paid, we will send the digital lease and all lessees must sign at that time. When we receive all signatures, the lease is yours and you can then leave the office.

If you choose cosigner as your guarantor, those will be sent out to the emails you've provided on your application within two business days.
