From The Pastor's Desk

"Unity in the church is so important that the New Testament gives more attention to it than to either heaven or hell. God deeply desires that we experience oneness and harmony with each other. Unity has to be more than just a word. It has to be something that the church is serious about. Unity was so important that you see more about Unity in the New Testament than heaven or hell. Jesus spent an entire Chapter (John 17) talking about and praying for Unity in the Church.

Mount Pleasant, we have to "examine ourselves". We have to take a serious look at what we are doing individually to cause us to not be unified collectively. Before Rosa Parks

Much is said about Rosa Parks not giving up her seat up on the bus in Montgomery, AL, but did you know she was not the first Black female to do so? Let's take a quick look at some who preceded her.



Born in March 1827, **Elizabeth Jennings Graham** was a teacher and civil rights figure. Her father was a free man and her mother was born enslaved. Her father patented a process for dry cleaning clothing and with the proceeds from the patent he bought his family's freedom. On Sunday, July 16, 1854, Graham was running late for her position as organist at her church. At that time, all the streetcars were privately owned and had segregated cars. She boarded the first streetcar that came by and was ordered to get off by the conductor. When she refused, he attempted to remove her by force but was unable to. Eventually, with the help of a police officer, she was ejected. Graham insisted that she had the right to ride on any New York City streetcar

that was available. Her father, Thomas Jennings, filed a lawsuit on behalf of his daughter against the driver, the conductor, and the company. Her case was handled by young attorney Chester A. Arthur, future President of the United States. The case was decided in her favor in 1855. The incident sparked an organized movement among Black New Yorkers to end racial discrimination on all streetcars, leading to the eventual desegregation of all New York City transit systems by 1865.




Born April 9, 1917, **Irene Morgan** was from Baltimore, MD. She was arrested in Middlesex County, Virginia in 1944 (while on a Greyhound bus), under a state law which imposed racial segregation in public facilities and transportation. At the time of her arrest and conviction, she was travelling on an interstate bus from Gloucester County in Virginia headed to Baltimore, Maryland that operated under federal regulations and law. In July 1944 (while on a Greyhound bus), she refused to give up her seat in what the driver said was the white section. The driver got off the bus and came back with the sheriff and a warrant for her arrest. She torn up the paper and threw it out the window. When the sheriff touched her to pull her out of the seat, she kicked him in the groin. Another sheriff was called. She explained to him about the physical altercation which had taken place with the first sheriff. After a conversation with him the second

sheriff got off and sent for a deputy. Morgan was arrested and charged with resisting arrest and violating Virginia's Jim Crow transit law. She agreed to pay a fine for resisting arrest but would not plead to the segregation violation. The NAACP Legal Defense Fund took up her case, with attorneys William H. Hastie and Thurgood Marshall as her legal counsel. The Virginia Supreme Court ruled she was in violation of the law. Her case, "Irene Morgan v. Commonwealth of Virginia, 328 U.S.373", was appealed to the United States Supreme Court, which ruled in a 6-1 decision in 1946 that the Virginia law was unconstitutional because it violated the Interstate Commerce Clause of the U.S. Constitution, protecting interstate travel and that only Congress could regulate interstate commerce.

Footnote: In 1960, in Boynton v. Virginia, the Supreme Court extended the Morgan ruling to include bus terminals used in interstate bus service.

Before Rosa Parks (continued)



Nine months prior to the arrest of Rosa Parks, **Claudette Colvin** refused to give up her seat to a white woman on a crowded bus in Montgomery, AL. On March 2, 1955, at the age of 15, she was arrested. Colvin was one of four plaintiffs in the first federal court case filed by Civil Rights Attorney Fred Gray, which challenged bus segregation in the city of Montgomery. In **Browder v. Gayle,** on February 1, 1956, a three-judge panel heard the case in U. S. District Court. In June of 1956, the judges determined that state and local laws requiring bus segregation in Alabama were unconstitutional. The case went to the U.S. Supreme Court on appeal by the State of Alabama, but the District Court's ruling was upheld on November 13, 1956. The Supreme Court affirmed the order to Montgomery and the state of Alabama to end bus segre-

gation. The Montgomery Bus Boycott (which had begun) was then called off. For many years, Colvin's pioneering efforts were not publicized; many believe because she was unmarried and pregnant. It is now widely believed that Montgomery civil rights campaigners did not credit Colvin due to her circumstances at the time of the incident.



Aurelia Browder was a civil rights activist in Montgomery, AL. On April 19, 1955, almost eight months before the arrest of Rosa Parks and a month after the arrest of Claudette Colvin, she was arrested for refusing to give up her bus seat to a white rider. She was convicted and fined for her alleged crime. Civil Rights Attorney Fred Gray filed suit. The court filing, Browder v. Gayle originally listed five plaintiffs: Aurelia Browder, Claudette Colvin, Susie McDonald, Jeanetta Reese and Mary Louis Smith. Browder was picked as the lead plaintiff because of her age (37). Both Susie McDonald and Mary Louis Smith were arrested on October 21, 1955. Two of the plaintiffs were teenagers and the other two were senior citizens. (Jeanetta Reese withdrew from the case soon af-

ter filing, probably due to intimidation from the white community). William A. Gayle (the namesake defendant) was the Mayor of Montgomery, but other defendants were Montgomery Chief of Police, Montgomery Board of Commissioners, Montgomery City Lines, Inc., two bus drivers and Alabama Public Service Commission. On June 5, 1956, judges released their decision that segregated buses violated the equal protection and due process guarantees of the Fourteenth Amendment and were therefore unconstitutional. Both the city and the state appealed the decision. On December 17, 1956, the Supreme Court upheld the ruling, issuing a court order to the state of Alabama to desegregate its buses.

While the Montgomery bus boycott, sparked by Rosa Parks' actions, gained lasting national attention, it was actually Browder's court case that resulted in segregation laws being declared unconstitutional. On December 19, 1956, federal marshals handed the mayor of Montgomery official notice to desegregate the Montgomery buses. They were desegregated the next day. The boycott had lasted 381 days.



A reminder that enforcement of **Real ID** will begin on **May 7, 2025**. You will need Real ID to board all domestic airline flights and to access federal facilities (i.e. buildings and grounds). Basically, your diver's license or ID card should have a star on it. If it does not, you will need to get a Real ID compliant card by going to your state drivers license department with proper documentation in order to obtain the proper ID.
