# REGULAR MEETING OF MAY 5, 2025

The Regular Meeting of the Board of Trustees of Austintown Township was held Monday, May 5, 2025 at the Senior Center; 112 Westchester Dr. Austintown, Ohio.

The meeting opened at 5:30 P.M. with a salute to the flag led by Chairperson Bruce Shepas.

Roll Call was as follows: Mrs. Deavers, present; Mr. Santos, present; and Mr. Shepas, present.

Mr. Shepas introduced the Board Members, Department Heads, and Sergeant of Arms.

Jason Murzda; Austintown Police Dept.

Works with the K-9 Unit. Explained how important that Dept. is to the township. The dogs are great in tracking, building searches, article searches, and criminal apprehension. Because of the lower numbers of officers in the township, a dog will work a building in minutes, whereas it may take 5 officers to do that same building, if not more. In another city, Officer Murzda created a K-9 donation program. The program is self-supportive and they now have 3 K-9s. Asked the Trustees to at least table the motion to see if they can come with alternative funding.

# ADMINISTRATOR'S REPORT

- Stated paving to start at the end of June, beginning of July.
- Noted the ¼% sales tax funds the township has been receiving will be ending soon).

# ROAD DEPARTMENT AND CEMETERY

The Township along with the Weathersfield Township will be doing a joint project to pave County Line Rd and West Webb Rd. This project was funded by a federal grant. The Trumbull County Engineer bid the TRU-County Line Rd./West Webb Rd Improvement Project. The low bidder was Kirila Contractors in the amount of \$906,027.00. Construction is expected to start mid-May or early June.

If said nuisances are not abated, controlled or provision for abatement, control, or removal is not made within SEVEN (7) DAYS or FOUR (4) DAYS for a repeat violation within 12 calendar months from the below date of adoption, the BOARD OF TRUSTEES will provide for the abatement, control, or removal, and any expenses incurred-\$500 minimum-by the Board of Trustees in performing that task will be entered upon the tax duplicate and will be a lien upon the land from the date of entry.
