PUBLIC STAFF MEETING OF MAY 12, 2025

The Public Staff Meeting of the Board of Trustees of Austintown Township was held Monday, May 12, 2025, at Town Hall, 82 Ohltown Road, Austintown, Ohio.

The meeting opened at 9:33 A.M. with a salute to the flag led by Chairperson Bruce Shepas.

Roll Call was as follows: Mrs. Deavers, present; Mr. Shepas, present; and Mr. Santos, present.

RESOLUTION #25-05-12-01: Motion by Mr. Shepas to appoint Mark D'Apolito as Fiscal Officer Pro Tem in the absence of Laura L. Wolfe.

Mr. Santos seconded the motion. Roll Call Vote: Mr. Santos, yes; Mr. Shepas, yes; and Mrs. Deavers, yes.

Harold Porter presented some suggestions and collaboration ideas to the Board.

- Take time to stamp down hot patch with roller don't just throw a shovel-full down and move on
- Ambulance services wages are increasing; need to hire 18 21 additional persons; Medicare & Medicaid re-imbursement fees are being reduced
- "Ideas to Saving" plan for employees
- Put some street lights at major intersections (Victoria) on timers; 10 p.m. to 4:00 a.m. – flashing yellow
- Shared services benefits with the school go to a consortium
- School will split the cost to repair the tennis courts at the Park since the school's tennis team uses the courts regularly

Park Matters:

Lawn service only for Westchester – considering out sourcing.

After discussing at length, Park was directed to mow Westchester once a week during April thru June and then every other week for months of July thru October.

Splash Pad: Discussion on the large water bills the Park is getting for the operation of the Splash Pad. Decision was made to reduce the hours of operation of the Splash

Pad.
