# PUBLIC STAFF MEETING OF NOVEMBER 17, 2025

- Detailed discussion with Assistant Chief O'Hara and Doug Estok regarding Engine 181 and the repairs needed to rebuild the engine totaling \$87,043.92 or a complete engine replacement totaling \$114,207.48. Neither Cummins or TSI Western Star have been able to determine what was ingested into the engine to cause the issue.
