RESOLUTION RES 25-11-22-01

A RESOLUTION DECLARING A STATE OF EMERGENCY

WHEREAS, Austintown Township, Ohio has been or is immediately threatened by a Building Explosion, affecting 141 apartments housing elderly and disabled residents, hazard, in the form of Building Explosion which commenced or is estimated to commence on November 22, 2025 at approximately 12:50 P.M., and;

WHEREAS, the Building Explosion resulted in an immediate evacuation response of approximately 24 hours; however, we expect all residents to be permanently displaced and where it was necessary to effectively coordinate response and recovery efforts, and;

WHEREAS, with regards to the physically handicapped and mentally disabled residents we expect the response and needs to extend indefinitely, and;

NOW, THEREFORE BE IT RESOLVED, we, the Austintown Township Board of Trustees declare that a state of emergency exists in the county and that we hereby invoke and declare those portions of the Ohio Revised Code which are applicable to the conditions and have caused the issuance of this proclamation, to be in full force and effect in the county for the exercise of all necessary emergency authority for protection of the lives and property of the people of Austintown Township and the restoration of local government with a minimum of interruption.

BE IT FURTHER RESOLVED, all public offices and employees of Austintown Township are hereby directed to exercise the utmost diligence in the discharge of duties required of them for the duration of the emergency and in execution of emergency laws, regulations, and directives – state and local.

BE IT FURTHER RESOLVED, all citizens are called upon and directed to comply with necessary emergency measures, to cooperate with public officials and disaster services forces in executing emergency operation plans, and to obey and comply with the lawful directions of properly identified officers.

BE IT FURTHER RESOLVED, all operating forces will direct their communications and requests for assistance and operations directly to the Austintown Township.

It was moved by Trustee Santos and seconded by Trustee Deavers that he foregoing Resolution be approved on this 22nd day of November, 2025.
