1. Basic Services of Funeral Director & Staff**/*	\$2,975
Our basic services fee includes, but is not limited to: the services of our funeral directors and staff to respond to the initial request for service; arrangement conference with the family/responsible parties; arrangement of services requested; preparation/filing of necessary authorizations, documents and permits; customary sheltering of remains; recording vital statistics; and staff assistance prior to, during and following the funeral, including coordinating the service plans with the cemetery, crematory, vault service, florist, and other third parties involved as required.	
In addition, this fee includes a proportionate share of overhead expenses relative to operating our facilities, such as an answering service to respond 24 hours a day to calls; accounting and billing, administrative and secretarial costs; insurance and legal expenses, governmental compliance; maintenance and utility expenses, equipment and inventory expenses and similar overhead expenses necessary to operate Parrott & Wood Chapel of Memories.	
This fee for our basic services and overhead will be added to the total cost of the funeral arrangements you select.	
This fee is already included in our charges for direct cremations, immediate burials, and forwarding or receiving of remains.	
2. Transfer of remains to the funeral home**/* (*within 25 mile radius of funeral home)	\$790
3. Embalming** Is not required by law. Embalming may be necessary, however, if you select certain arrangements, such as a funeral with viewing. If you do not want embalming, you usually have the right to choose an arrangement that does not require you to pay for it, such as direct cremation or immediate burial.	\$900

Forwarding of Remains to Another Funeral Home.....	\$4,415
This fee includes our basic services of funeral director & staff, local removal of remains, embalming and other preparation of remains and necessary authorizations. This fee does <u>not</u> include merchandise, shipping charges, mileage fees, nor does it include visitation, rites or ceremonies prior to forwarding of the remains.	
Receiving of Remains from Another Funeral Home.....	\$3,145
This fee includes our basic services of funeral director & staff, and local transportation of remains to the cemetery or crematory. This fee does <u>not</u> include merchandise, mileage fees, visitation, rites or ceremonies.	
Immediate Burial.....	\$4,290
Our fee for immediate burial includes: basic services of funeral director & staff, local removal of remains, casketing, necessary authorizations, and local transportation to the cemetery. This charge does <u>not</u> include embalming, the use of facilities or staff for any visitation, rite or ceremony, public or private, prior to burial. It also <u>does not</u> include grave opening, or additional merchandise required by cemetery authority or others.

Direct Cremation.....	\$3,765
Our fee for a direct cremation (without ceremony) includes: <u>limited services</u> of funeral director & staff, local removal of remains, filing of necessary documents and authorizations. This charge <u>does not</u> include viewing, visitation, private or public ceremony prior to cremation, or preparation of any obituary or printed materials.	
If you want to arrange a direct cremation, you can use an alternative container. Alternative cremation containers encase the body and may be made of materials like unfinished wood, fiberboard, composition materials, pressed-wood or other similar non-metal materials (with or without an outside covering). The containers we provide are, a heavy cardboard box, alternative containers, or wood caskets.
