## Our Vision, Strategic Plan, and Impact

In 2021, Illinois Green launched a five-year Strategic Plan with a vision to make net zero feasible, affordable, and commonplace across Illinois by 2050.

Since then, we have made meaningful progress towards this vision by educating thousands of building professionals each year, helping advance landmark statewide policies like the Clean and Equitable Jobs Act, and demonstrating that high-performance buildings are achievable anywhere in the state through new projects like the Building Energy Hub.

Illinois Green's 2026-2030 Strategic Plan, **"Scaling High Performance,"** builds on these strong foundations. Over the next five years, we will grow our impact by focusing on key areas such as advancing decarbonization standards, broadening our reach to all Illinois communities, and extending education to the full spectrum of those working in the building industry. It was another banner year for the Building Energy Hub, our project to broaden the adoption of sustainability best practices with technical and financial solutions. We started 2025 by relaunching the Hub with a brand-new look and realigned our programming to better fit the needs of our audience. In addition to the new tools and resources that were published, we also launched The Building Energy Pod, a new podcast for industry professionals navigating the world of building retrofits, green construction, and energy efficiency.

## Examples of Our Work



### Women in Green Building Leadership Luncheon

Since 2016, Illinois Green has hosted the annual Women in Green Building Leadership Luncheon, where we convene our community to celebrate and engage with the influential women at the forefront of sustainable design and construction. **Our theme for 2025 was “Growing Your Impact,”** where we explored how green building professionals can elevate their voices and activate their networks to advance sustainability to the next level.

### Getting to Zero Illinois Tech Forum + Limelight Celebration

We hosted our first-ever **Getting to Zero Tech Forum** — a fresh new take on our signature annual event that featured a collection of fast-paced presentations by 20 leading building technology experts on how a variety of innovations are critical for moving the needle on decarbonization. We wrapped up the evening with our Limelight Celebration & Emerald Awards Ceremony, where we recognized the region’s top achievements in sustainability.

## Policy Development and Implementation

Building industry professionals were at the forefront of advancing green building policy at the state and local level in 2025. To build on this momentum, we will continue to leverage their voices so that all leaders across the state understand the benefits of policies like benchmarking and stretch energy codes. **That's why we launched the Illinois Clean Building Commitment** — to identify new champions for green buildings and provide the education and support to take action.

## The Building Energy Pod

We launched The Building Energy Pod in 2025 to provide **a new platform for candid conversations about the challenges and opportunities in sustainable design and construction**. Hosted by Illinois Green Communications Manager Matt Watson, each episode features in-depth conversations with industry leaders, innovators, and changemakers who are shaping the future of high-performance buildings.



## Illinois Green Schools Project

The Illinois Green Schools Project is an annual sustainability action and recognition program for K-12 schools in Illinois. We help educators engage students and school stakeholders in hands-on projects that improve health, efficiency, and environmental impact. **After receiving overwhelmingly positive feedback** from program updates implemented in 2024, we have welcomed 21 schools into the 2025-2026 cohort, with Green Teams utilizing the updated framework to design and implement creative, impactful sustainability projects.
