Supreme Court justices are appointed by Florida's Governor, then elected by retention which is a Yes or No question. If there are more Yes votes than No votes the justice is retained.

County and Circuit judge races begin in the Primary Election. To win in the primary a candidate must receive 50% of the votes plus one vote. If not, the two candidates with the highest amount of votes will appear on the General Election.
