You are hereby notified that you are potentially ineligible to be registered to vote. Failure to respond to this notice within 30 days may result in a determination of ineligibility by the Supervisor of Elections and removal of your name from the statewide voter registration system. You may contact the Supervisor of Elections office within 30 days to receive information regarding the basis for the potential ineligibility and the procedure to resolve the matter. If further assistance is needed, contact the St Johns County Supervisor of Elections office. If you deny that this information is accurate, you have the right to request a hearing with the Supervisor of Elections for the purpose of determining eligibility.

If you attempt to vote at an early voting site or your normal election day polling place, you will be required to vote a provisional ballot. If you vote by mail, your ballot will be treated as a provisional ballot. In either case, your ballot may not be counted until a final determination of eligibility is made. If you wish for your ballot to be counted, you must contact the Supervisor of Elections office within 2 days after the election and present evidence that you are eligible to vote.

Por la presente se le notifica que es potencialmente inelegible para registrarse para votar. La falta de respuesta a este aviso dentro de los 30 días puede resultar en una determinación de inelegibilidad por parte del Supervisor de Elecciones y la eliminación de su nombre del sistema estatal de registro de votantes. Puede comunicarse con la oficina del Supervisor de Elecciones dentro de los 30 días para recibir información sobre la base de la posible inelegibilidad y el procedimiento para resolver el asunto. Si necesita más ayuda, comuníquese con la oficina del Supervisor de Elecciones del Condado de St Johns. Si niega que esta información sea precisa, tiene derecho a solicitar una audiencia con el Supervisor de Elecciones con el fin de determinar la elegibilidad.

Si intenta votar en un sitio de voto temprano o en su lugar de votación normal el día de las elecciones, se le pedirá que vote con una boleta provisional. Si vota por correo, su boleta será tratada como una boleta provisional. En cualquier caso, su boleta no puede ser contada hasta que

se tome una determinación final de elegibilidad. Si desea que su boleta sea contada, debe comunicarse con la oficina del Supervisor de Elecciones dentro de los 2 días posteriores a la elección y presentar evidencia de que es elegible para votar.
