Alli Palmbach presented an outline of what she was working on over the summer. She reviewed the
mapping done in 2018 to 2019 and showed how the spread of wild parsnip had been contained. The maps
will be printed in book format and made available to the township. A suggestion was made to distribute
these to Rice County and MnDOT. It was also suggested that a position statement be written regarding the
progress made.

 - Glen Castore made a motion to approve moving \$100,000 from the Annexation Tax Fund to the First National checking account, Glary Eblin seconded, all approved.

- 1. Mail
 - a. The Clerk reviewed incoming mail for the month including the annexation tax repayment from Northfield, town aid from the State, and the upcoming L&R meeting.

Planning & Zoning

- 1. Staff Report
 - o Jim Braun reviewed the permits to date.
 - Concerns regarding Inspectron have been raised by Jim Braun. He will create a list of these concerns and bring them to a meeting on Wednesday, August 21st.
- 2. Rice County C.U.P authority update
 - Glen Castore suggested talking to Sara Folstad to get her assistance in resolving this. Jim Braun will follow up with this suggestion.

 Gary Ebling requested that Jim Braun schedule Terry Overn to attend the Wednesday, August 28th, meeting to review the mining operation and other possibilities.

3. Update on nuisance properties

- o Jim Braun noted that the Catholic Church contacted him regarding the Hollinger property. They will be offering assistance to Mrs. Hollinger.
- Regarding the house at 13192 Dahle Ave., Jim B. has spoken with the home owner. There is the possibility that the property will be for sale. Jim B. will continue to monitor this.
- O About half of the nuisance property owners have been approached by Jim Braun. A number of these have indicated that the properties will be cleaned up. All properties will continue to be monitored.

4. 12425 Ebel Ave Easement

 The Township cannot acquire private easements for individual residents or provide legal advice. John Holden will talk to the homeowner to let them know that they are responsible for acquiring an easement if they so choose.

5. House on 1st Timberlane

- o Jim Braun was not able to get a hold of the homeowner.
- o Rieland Builders is getting bids to complete demolition of the house.

6. C.U.P for IPS Solar

 IPS did not provide the information requested within the set timeline. When the information is available, the C.U.P will be brought before the Board during a Wednesday meeting.

7. Solar Garden Fee Amendment

- Jim Baun reviewed the need for an escrow when applications submit a request for approval of a solar garden. This escrow will cover the costs associated with research on the application.
- Glen Castore made a motion to approve Ordinance 2019-02 Amended Fee Schedule for Bridgewater Township, Gary Ebling seconded, all approved.

8. Solar Garden cover crops

 Mike Groth requested that Jim Braun review the prairie restoration planting under the existing solar gardens and request that new installations include cover crops while the prairie gets established. It was noted that a prairie can take three years to show.
