- Monthly updates between Board of Supervisors and Planning Commission
  - a. John Klockeman reviewed the need to maintain good communication between the Supervisors and Planning Commissioners.
  - b. Larry Alderks discussed the need to establish channels of communication between not only the Board of Supervisors and Planning Commission, but also Rice County, Dundas, and Northfield.
  - c. A request was made for the unofficial minutes to be distributed to both Board of Supervisors and Planning Commission. Also, during a meeting, an agenda item will be added to provide updates on the other group.
  - d. Bruce Morlan suggested having a volunteer attend the Northfield and Rice County Planning Commissions and report back to the group.

    - ii. Larry Alderks volunteer to cover the Northfield Planning Commission meetings.
    - iii. Glen Castore noted that relations between the Township and Rice County are improving.

- Industrial Zone Update and next steps
  - a. Kathleen Kopseng reviewed the updated information from Cindy Nash. This information will be sent out on Monday, May 24<sup>th</sup>, to the Planning Commission.
  - b. Glen Castore reviewed the information on the 140<sup>th</sup> Street upgrade from Bolten & Menk will be available at the end of May. The proposed upgrade to the 140<sup>th</sup> Street railroad crossing was reviewed also. Supervisor Castore reviewed plans by Rice County to place a water tower near the intersection of Cty Rd 1 and I35. Rice County is also looking at zoning along I35.
- Dundas Annexation Agreement update
