### New Business

- Set special/joint meeting with Board of Supervisors joint meeting will occur on Saturday, March 17, 10:30am. This meeting will be a planning and training session.
- Development proposal from Edward Koktavy.
  - Mr. Koktavy would like to see Comus junction revived as a possible housing development or commercial area.
  - Mr. Koktavy reviewed information from Trent McCorkel at Rice County. Per McCorkel, Rice County would like to know what the township plans are for this area.
  - Beacon maps were reviewed to determine what is currently happening in the area and what the topography is.
  - Jim Braun will provide SMC's phone number to Koktavy to follow up with SMC to determine if they are interested in any future mining applications.
  - Gary Ebling suggested that a Supervisor speak with McCorkel to determine Rice Counties interested and restrictions for the area.
  - Kathleen Doran-Norton requested that the Planning Commission give the Board a recommendation.
  - Kathleen Doran-Norton suggested that a future industrial zoning overlay be considered.
  - John Klockeman suggested sections 31, 32 (to hwy 3), and 29 be considered for a rural commercial industrial overlay. (see red line map attached)

- Jeff Johnson made a motion to move forward with a proposal to the Board of Supervisor to research the creation of an approximate 950 acre rural commercial industrial overlay (per red line map attached), with standards to be developed after further discussion, Kurt Schrader seconded the motion, all approved.
  - Kathleen Doran-Norton noted that residents of the township would be involved in future discussion regarding this.
- Request from Larry Alderks to discuss a process to generate ideas for future development.
  - A discussion was held regarding the City of Northfield's possible future development. A recent Northfield News article was discussed.
