- Ray Larson made a motion to approve the minutes of September 27, 2018, Jeff Johnson seconded, all approved.

- New Business
 - o Brief update on the Codification process.
 - Carolyn Braun presented the code with changes.
 - Included in the changes were requests made during past meetings.
 - A public hearing will be needed for the zoning changes. A notice will be placed for a public hearing in November.
 - Code changes that have been made by the county and state have been included in the new update.
 - Clerical errors are being reviewed and corrected.
 - Following the public hearing in late November, the Codification will go before the board in December.
 - Carolyn Braun advised reviewing the code by chapter as it is very long.
 - Temporary Portable Structures
 - Jim Braun reviewed the restrictions placed on temporary portable structures by other areas.
 - His findings show that other areas do not allow these types of structures on less than a ½ acre.
 - Mr. Braun advised the Commission to wait and see if the county would allow the township to have small sub-divisions.

 - The project is waiting for Rice Cty SWCD to test the soil prior to beginning. The application for the solar farm should come in for the January Planning Commission meeting.
- Update on clean-up actions
 - Jim Braun reviewed the efforts to date to get the properties on Armstrong Rd and Edgebrook cleaned up. He noted that both residents are hoarders and asked the commission if there were any other avenues that we could pursue as this is considered an illness.
 - It was decided that as long as the issue is confined to the inside of the house and does not affect others, the township would not pursue legal action.
