 - It was decided to stay with the current vision statement.
 - Agriculture
 - Agriculture is the primary focus of the township
 - Maintain building/structure integrity of farms in the interest of public safety
 - Maintain farm to market transportation
 - Maintain a low tax burden to ensure viability of farming
 - Minimize disruption of agriculture land
 - Support ALL scales of agriculture
 - Establish a standard of land quality rating and be consistent
 - Continue to refine the definition of "rural character" as it relates to varies land uses
 - Residential
 - Provide opportunities for housing without disrupting agriculture production efficiencies
 - Work with local government authorities to explore housing density options:

 - Park like restoration of abandoned gravel mines

 - Preserve natural spaces to retain rural character of the township
- Sewer & Water
 - Transition to common septic and common wells
 - Storm water management
 - Effective best practice for storm water management that speaks to maintaining water quality
 - Storm water management in support of efficient agriculture production
 - Continue to improve accommodation of increasingly severe weather events
- Transportation
 - Maintaining high quality farm to market route
 - As usage patterns dictate, the township will evaluate transitioning roads to other jurisdictions.
 - Glen Castore would like to know which state statute says what the condition of the road needs to be when it is turned back. Carolyn will research this.
 - Maintain long term road maintenance program (include maps)
 - Respect farm traffic
 - Incorporate road policy
 - Road policy will recognize all uses including agriculture and pedestrian use.
- Parks and Recreation
 - Mill Town Trail Bike and pedestrian
 - Ensure user safety while maintaining natural character /environmental beauty to promote bike and pedestrian pathways
 - Support/enhance the use of the Cannon River Wilderness Park
 - Add maps showing parks
- Community Facilities
 - New town hall evaluate need for town hall and community area
- Economic Development
 - Broaden tax base to ensure sustainability of agriculture as the primary form of business
 - Encourage development of a broader cross section of housing stock
 - Industrial
