A motion was made by Adam Lightfield to approve Ryan Delzer as the assistant registrar. The motion was seconded by Joanna Kapsch. Motion carried unanimously.

A motion was made by Adama Lightfield to use Creed Bookkeeping to handle SSA's bookkeeping for 1 year, specifically March 31st, 2026 - April 1st 2027. The motion was seconded by Joanna Kapsch. Motion carried unanimously.
