- Ryan Fremont motioned to donate \$501 to the Bauerball camp that a lot of our members are attending in June. Adam Lightfield seconded the motion. The motion carried unanimously.
- Adam Lightfield motioned to spend no more than \$300 on a popcorn machine for the concession stand. Kim Kinney seconded the motion. The motion carried unanimously.
