Water Pollution Control Plant – Richard Dunning II

The new Crane has arrived and we are waiting for construction to be completed, hopefully by Friday. The plans to replace three main sewage pumps will then move forward. Substantial completion of the WPCP project was initially set for late February 2026. There will be a construction project meeting on Tuesday to discuss progress and the possibility of extending the time frame. A second generator test was performed, resulting in no power surges. Studies are

being conducted on the sludge process and we are waiting for lab test results to come back for PFOA levels.

Department of Public Works – Mitchell Cornish

Crews are busy with building maintenance, plowing and salting. We have used 500 ton of salt so far this season. We are seeing interest in the newest Boces House #14 on Canisteo Street, which is still under construction. The BID for Boces House #13 on Madison Ave has been published and there has been interest in this home as well. The new salt truck is performing well. Sidewalk work on Center Street continues, including the installation of handicap accessible plates. Sixteen streets were paved last year and a new list of streets is being compiled.

Water Treatment Plant – Caleb Mitchell

The plant is running well. Water usage is high, at 2.6 million gallons per day. All reservoirs are full again thanks to recent snowfall. R.E. Kelly did some concrete restoration work recently at the plant, sealing up cracks. Joe Brungard is still out of work recovering from a recent injury, and Tony Sciotti has stepped in to work his shift. Caleb continues to learn and has stepped into Tony's shift, which he is enjoying.
