A RESOLUTION AUTHORIZING THE MAYOR OF THE CITY OF HORNELL TO EXECUTE A GRANT AGREEMENT WITH THE NEW YORK STATE ENVIRONMENTAL FACILITIES CORPORATION (EFC) FOR ENGINEERING PLANNING GRANT NO. 2293 – WATER POLLUTION CONTROL PLANT SOLIDS DEWATERING AND DISPOSAL EVALUATION

WHEREAS, the City of Hornell has applied for and been awarded funding under the New York State Environmental Facilities Corporation (EFC) Wastewater Infrastructure Engineering Planning Grant (EPG) Program; and

WHEREAS, such funding, identified as EFC Engineering Planning Grant No. 2293, will support the Water Pollution Control Plant Solids Dewatering and Disposal Evaluation, which is necessary to assess, plan, and improve the City's wastewater treatment operations; and

WHEREAS, it is in the best interest of the City of Hornell to accept said grant and to enter into an agreement with the Environmental Facilities Corporation for the administration of these funds;

NOW, THEREFORE, BE IT RESOLVED, by the Common Council of the City of Hornell, that **Mayor John J. Buckley** is hereby authorized and directed to execute all necessary documents, including the **Engineering Planning Grant Agreement No. 2293**, and any and all associated forms, certifications, and assurances required by the Environmental Facilities Corporation to **carry out** the acceptance and administration of this grant; and

BE IT FURTHER RESOLVED, that the Mayor, City Clerk, and other appropriate City officials are authorized to take any and all actions necessary to carry out the intent of this Resolution.

A RESOLUTION AUTHORIZING A LOCAL MATCH COMMITMENT OF TEN THOUSAND DOLLARS (\$10,000) IN CONNECTION WITH THE ENVIRONMENTAL FACILITIES CORPORATION (EFC) ENGINEERING PLANNING GRANT NO. 2293 – WATER POLLUTION CONTROL PLANT SOLIDS DEWATERING AND DISPOSAL EVALUATION

WHEREAS, the City of Hornell has applied for and been awarded funding under the New York State Environmental Facilities Corporation (EFC) Wastewater Infrastructure Engineering Planning Grant (EPG) Program, identified as Engineering Planning Grant No. 2293, to support the Water Pollution Control Plant Solids Dewatering and Disposal Evaluation; and

WHEREAS, participation in the EPG Program requires a local match from the City to supplement the grant funding provided by the Environmental Facilities Corporation; and

WHEREAS, the Common Council of the City of Hornell recognizes the importance of this project in assessing, planning, and improving the City's wastewater treatment operations to ensure environmental compliance and operational efficiency;

NOW, THEREFORE, BE IT RESOLVED, by the Common Council of the City of Hornell, that the City hereby commits to providing a local match of Ten Thousand Dollars (\$10,000) toward the total project cost associated with EFC Engineering Planning Grant No. 2293; and

BE IT FURTHER RESOLVED, that such local match shall be paid from available funds within the City's approved budget or other appropriate funding sources as determined by the City; and

BE IT FURTHER RESOLVED, that the Mayor, City Clerk, and other appropriate City officials are hereby authorized to take any and all actions necessary to carry out the intent of this Resolution and to fulfill the City's local match obligation under the Engineering Planning Grant Agreement No. 2293.
