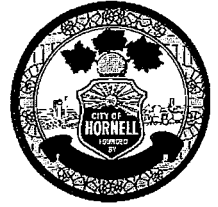

WHERE AS, the City of Hornell has been awarded a grant from Bridge NY funds for the replacement of Canisteo Street over Spencer Creek Culvert (OSC Contract #D041518), City of Hornell, Steuben County, P.I.N. 6755.88. The estimated to cost of the design phase is \$15,000. Of which, \$15,000 is expected to be received from state aid with no local share to the city. Instead of incurring costs to finance the design phase of said project, the city will use its own funds.

NOW, THEREFORE, BE IT RESOLVED, by the Common Council of the City of Hornell, NY that the City Chamberlain is hereby authorized to transfer from the General Fund to the Capital Fund to pay said design costs for the replacement of Canisteo Street over Spencer Creek Culvert.
