Mayor Buckley talked about the purpose of the meeting tonight. Well, first and foremost, I appreciate everyone being flexible. As you know, this is grant season. We're coming up against a hard deadline to submit the CFA's. We passed a slew of resolutions at the last meeting, so thank you for that. This meeting, the agenda is solely for one item, and that is the New York Main Street application. This application was a little bit different than some of the others that we've worked on, in that it takes a little bit more time and certainly outreach. Our city planner, Heather Reynolds, has been working nights and weekends. We were even corresponding yesterday trying to put the finishing touches on the grant application as well. The Main Street grant application, as some of you may know, and certainly John and Jim have been around for prior applications, this has to do with the downtown business owners. What we would like to do tonight is ask the council to approve the grant application so we can submit on behalf of the city. We've got the City Planner Heather Reynolds here tonight to talk about the grant in more detail.

Heather Reynolds went into detail about the grant, the projects and the estimated cost for each property owner. The nice thing about the Main Street grant is we can have a target area. The target area for this grant is buildings on Main Street between Seneca Street and Church Street. The four properties are 96 Main Street, 120 Main Street, 134-136 Main Street and 103-113 Main Street.
