Miscellaneous:

An application for the Hornell Area Wind Ensemble Summer Concert was approved, Ayes All.

Bud Burdett said that they are doing a lot of inspections. The old Planned Parenthood building is set for demolition and they will be building a Tim Horton's at that site. The building at 10 Cottage Avenue is still not down. The adjacent wall is an issue, as it is built with interior bricks. An exterior wall will need to be constructed. A structural engineer will have to be brought in. The house at 82 Hill street has been demolished. The land bank has been very helpful with these demolitions.

Chief Murray spoke of the three new officers. They will be done with field training at the end of the week. Bud stated that in the incidents that he has been on, the new officers have been doing great, they are real professional and confident. Chief is waiting on the results of the Civil Service exam. Their physical agility test is on the 30th of this month. Dan Murray has been accepted into a Secret Service school in Alabama. It will be three weeks in March. Everything is taken care of and paid for by Secret Service. Once it is complete, they will supply us with all of the equipment necessary to download information from phones and computers. He has actively done over 25-30 search warrants on these items and the Secret Service has seen the need for this service in this area. Murray and Emo just finished a two-day course on Bitcoin in Buffalo. Cell phones and computers are more involved in crimes now. The department is still dealing with Narcan deployment regularly. Having their officers trained in this has been helpful. They have only had one death.

Chief Brzozowski said he has had meetings with home healthcare and public health. We have an aging population and there are people that are living alone and some don't know who to reach out to for help. The Captains are aware of who to call for help and if they see certain conditions, they let the doctors at the hospital know if there might be issues. The new hospital medical director has been great and is always a phone call away. He's been at the station for some trainings and has been working with the department to help them make things work. They have had outreach trainings and the director is bringing the hospital up to speed with this. There was a mass casualty event. All stabbing victims were stabilized on scene and brought to the trauma center and the hospital. There was a language barrier which hindered things. The three paramedic students are doing well. Their grades are currently between 78 and 82. After this week, they will be over the hump and everything will start to make more sense.
