WHEREAS, the City of Hornell obtained the abandoned County Courthouse located at 12 Allen Street in the City of Hornell from the County of Steuben, and

WHEREAS, a developer has contacted the City of Hornell with the desire of developing said property into a distillery, and

WHEREAS, the Common Council for the City of Hornell finds that the development of said property into a distillery conforms to the City of Hornell's master plan.

NOW, THEREFORE, it is hereby resolved that:

1.) The Common Council for the City of Hornell hereby authorizes the sale of what was formerly known as the Steuben County Courthouse, located at 12 Allen Street in the City

of Hornell, to Robert W. Bates under the terms and conditions of the purchase agreement attached hereto, provided the attached contract contains the following provision:

The city shall retain a reversionary interest which shall run with the land. The interest shall provide that the grantee will provide the city with an approvable redevelopment plan within 18 months of the transfer of the deed. It will further provide that the grantee will obtain a certificate of occupancy for said property within 5 years of the transfer of the deed. A violation of the reversionary clause will result in the property reverting back to the city. In the event the grantee wishes to sell said property, the city will not unreasonably withhold its consent and the city agrees to negotiate in good faith with the new buyer in order to redevelop said parcel.

2.) The Mayor for the City of Hornell is hereby authorized to execute any and all necessary documents in order to effectuate said transaction.

WHEREAS, the City is very supportive of this effort to develop the remaining acreage to productive commercial use, the Common Council of the City of Hornell authorizes the City Attorney to prepare such legal documents required to finalize this transaction, and further authorizes Shawn D. Hogan, Mayor, or his successor, to sign such legal documents to make the transfer of title, under the terms and conditions outlined in this resolution.
