Quality of Life Committee

A Quality of Life meeting was held in the second floor conference room at City Hall on July 10, 2018 at 6:17pm. In attendance: Alderman Melissa Ponticello, Alderman Fred Lehman, Alderman Dan Warriner, Alderman Steve Shinebarger, Mayor John Buckley, Fire Chief Dan Smith, Police Chief Ted Murray, Codes Enforcement Director Bud Burdett and Chairwoman Jessica Cleveland

Special Guests include: Laura Vetter, Community Service Supervisor, Mohammed Razak, Architect and Bryan O'Donovan, CEO from St. James

The committee received a slideshow presentation of plans for the new hospital and services offered, including schematics of the building and traffic flow. The new hospital will provide 15 inpatient beds, 6 observation beds and 12 beds in the emergency dept. and several other services including laboratory, OR services, and a multi-specialty suite. Much emphasis was on providing natural light and high efficiency of space and connectivity. A medical office building housing primary care, physical therapy and other outpatient services is adjacent to the hospital with opening of some services in November 2018.

Several questions were provided, including areas for growth of services and employment. Hospital staff was very positive in their discussions and indicated both are dependent

upon use of services and data. This includes maternity services, which would require at least an annual amount of 300 births per year. The hospital remains open to exploring and expanding services in the years to come.

Chief Murray provided a police dept. update. He indicates officers are working diligently to trace back and make arrests related to 2 overdoses. Discussion was held regarding an increase of door to door sales/solicitation with the summer season. Chief Murray encouraged residents to reach out to the police dept. with any concerns.

Chief Smith reviewed there have been no concerns related to recent heat wave. He also reported education and outreach services such as an event on this date with Alstom regarding safety, including education regarding use of AEDs.

Codes dept. reviewed several troublesome properties will be auctioned in the upcoming county tax auction. Zombie properties currently stand at about 7 or 8 city wide. There has been much improvement with assistance from financial services to assist with lender or home owner identification.

With no further business, there was a motion to adjourn at 7:35pm by Melissa Ponticello, seconded by Dan Warriner.

BE IT RESOLVED, by the affirmative vote of not less than two-thirds of the total voting strength of the City Council of the City of Hornell, Steuben County, New York, as follows:

<u>Section 1.</u> The replacement of Canisteo Bridge in and for the City of Hornell, Steuben County, New York, is hereby authorized at a maximum estimated cost of \$400,000.

Section 2. The plan for the financing of the aforesaid maximum estimated cost is by the issuance of \$400,000 serial bonds of said City, hereby authorized to be issued therefor pursuant to the provisions of the Local Finance Law; provided, however, that the amount of bonds to be issued shall be reduced to the extent of grants received for such purpose.

<u>Section 3.</u> It is hereby determined that the period of probable usefulness of the aforesaid specific object or purpose is twenty years, pursuant to subdivision 10 of paragraph a of Section 11.00 of the Local Finance Law.

<u>Section 4.</u> The faith and credit of said City of Hornell, Steuben County, New York, are hereby irrevocably pledged for the payment of the principal of and interest on such bonds as the same respectively become due and payable. An annual appropriation shall be made in each year sufficient to pay the principal of and interest on such bonds becoming due and payable in such year. There shall annually be levied on all the taxable real property of said City, a tax sufficient to pay the principal of and interest on such bonds as the same become due and payable.

<u>Section 5.</u> Subject to the provisions of the Local Finance Law, the power to authorize the issuance of and to sell bond anticipation notes in anticipation of the issuance and sale of the serial bonds herein authorized, including renewals of such notes, is hereby delegated to the City Chamberlain, the chief fiscal officer. Such notes shall be of such terms, form and contents, and shall be sold in such manner, as may be prescribed by said City Chamberlain, consistent with the provisions of the Local Finance Law.

<u>Section 6.</u> All other matters except as provided herein relating to the serial bonds herein authorized including the date, denominations, maturities and interest payment dates, within the limitations prescribed herein and the manner of execution of the same, including the consolidation with other issues, and also the ability to issue bonds with substantially level or declining annual debt service, shall be determined by the City

Chamberlain, the chief fiscal officer of such City. Such bonds shall contain substantially the recital of validity clause provided for in Section 52.00 of the Local Finance Law, and shall otherwise be in such form and contain such recitals, in addition to those required by Section 51.00 of the Local Finance Law, as the City Chamberlain shall determine consistent with the provisions of the Local Finance Law.

<u>Section 7.</u> The validity of such bonds and bond anticipation notes may be contested only if:

- 1) Such obligations are authorized for an object or purpose for which said City is not authorized to expend money, or
- 2) The provisions of law which should be complied with at the date of publication of this resolution are not substantially complied with, and an action, suit or proceeding contesting such validity is commenced within twenty days after the date of such publication, or
- 3) Such obligations are authorized in violation of the provisions of the Constitution.

<u>Section 8.</u> This resolution shall constitute a statement of official intent for purposes of Treasury Regulations Section 1.150-2. Other than as specified in this resolution, no monies are, or are reasonably expected to be, reserved, allocated on a long-term basis, or otherwise set aside with respect to the permanent funding of the object or purpose described herein.

<u>Section 9.</u> This resolution, which takes effect immediately, shall be published in summary form in the official newspaper of said City for such purpose, together with a notice of the City Clerk in substantially the form provided in Section 81.00 of the Local Finance Law.
