



# 2025 YEAR-END IMPACT REPORT

## Dear Friends,

Thank you for your interest, support, and partnership in the ministry of FCA in the El Paso Area! As we move into 2026 it is a great time to reflect on God's blessings and provision for the past year. During 2025 we saw God move in many ways on campuses, at area events, and at summer camps. As I have often said, sports opens doors for the Gospel like almost nothing else, and this has allowed us to minister to over 1,000 coaches and athletes on a regular basis across El Paso, Far West Texas, and southern New Mexico.

This year we were able to grow to 35 campus-based Huddles, with several others ready to start soon. Our work with UTEP and NMSU sports teams flourished through chapels, Bible Studies, and discipleship relationships. Our weekly Bible Study in the Juvenile Detention Center has also continued steadily. During the summer we were able to send over 100 athletes, coaches + families, volunteers, and staff to Leadership Camp in Abilene (for students) and Coaches Enrichment Camp in Ruidoso (for coaches and families). We also held numerous trainings, community-engagement events, and fundraisers throughout the year. These life-changing ministries would not be possible without support from people, churches, and businesses like you!

Through all of this 40+ athletes and coaches gave their lives to Jesus Christ or rededicated themselves to God, with 7 of these getting baptized in August. We were able to give out almost 500 Bibles, grow discipleship relationships, and plant countless seeds with the Gospel. Yet there is so much work still to be done! Our most important next step is to hire more full-time staff. As you will see on the back, getting Monthly Financial Partners for Scott Quiroz (Prospective Area Rep for East El Paso) is our #1 priority. 




**Hiring Scott as full-time staff is our #1 need for El Paso FCA right now! Scott needs Monthly Financial Partners to get hired.**
