DISTINGUISHED U.C. BERKELEY LAW PROFESSOR JOHN YOO WILL DISCUSS "THE SUPREME COURT AND THE TRUMP PRESIDENCIES" AT OUR OCTOBER 21 REPUBLICAN CLUB DINNER

U.C. Berkeley Law Professor John Yoo will be the guest speaker at our Republican Club dinner on October 21, at 5:15 p.m. in the Event Center's Tahoe Room.

John Yoo is the Emanuel Heller Professor of Law at the University of California at Berkeley. He is also a Senior Research Fellow, Civitas Institute, University of Texas at Austin, and a Nonresident Senior Fellow at the American Enterprise Institute.

Professor Yoo's most recent book, The Politically Incorrect Guide to the Supreme Court, co-authored with Robert Delahunty, was published in 2023. His other books include Defender-in-Chief: Trump's Fight for Presidential Power; Striking Power: How Cyber, Robots, and Space Weapons Change the Rules for War, Point of Attack: Preventive War, International Law, and Global Welfare, and Crisis and Command: A History of Executive Power from George Washington to George Bush. Professor Yoo has also published more than 100 articles in academic journals on subjects including national security, constitutional law, international law, and the Supreme Court. He regularly contributes to the editorial pages of the Wall Street Journal, New York Times, Washington Post, Los Angeles Times, and National Review.

Professor Yoo has served in all three branches of government. He was an official in the U.S. Department of Justice, where he worked on national security and terrorism issues after the 9/11 attacks. He served as general counsel of the U.S. Senate Judiciary Committee. Professor Yoo graduated from Yale Law School and summa cum laude from Harvard College and served as a law clerk for Supreme Court Justice Clarence Thomas.

Join us October 21 for dinner catered by the Creekside Grill. Hypocrisy: You don't do what you say.





"THE PLAGUE OF LOOTERS" AKA THE "KINDNESS" OF THE DEMOCRAT LEFT

In recent years, many California businesses have endured rampant shoplifting and even mass invasions by organized looters. Major shopping areas, like Market Street and Union Square in San Francisco, have been devastated by crime. Many shops and restaurants located in the city are now vacant. Not only has this destroyed family businesses, it has also placed commercial property owners in a potentially perilous financial position.

The dangerous and filthy situations that exists in many major Democrat-run cities have largely killed off tourism and convention business. Downtown office workers have become fearful of the risks posed by thieves and bums. Parked cars are often broken into. "Homeless" bums obtain money for their drugs through car break-ins, looting, and robbery.

Police officers have their hands tied by a combination of police department defunding and terrible laws like Propositions 47 and 57. Hard-left district attorneys in many leftwing communities are unwilling to charge perpetrators with crimes. Police officers have come to realize that arresting looters and other thieves is pointless because such wrongdoers face little or no legal penalties.

Under Proposition 47, the theft of less then \$950 per event is only a considered a misdemeanor—a citation offense. Previously, the theft of \$400 or more could be charged as a felony.

Under Proposition 57 convicted felons receive early release. Incarceration is supposed to serve three critical societal functions: 1) to discourage repeat criminality, 2) the risk of prison discourages those considering criminal acts, and 3) prison isolates dangerous, destructive criminals from the public for a period of time. Proposition 57 undermines these important protections of the law-abiding community.

Proposition 36, a tough-on-crime measure passed in 2024 to repeal parts of Proposition 47, is insufficient to restore common sense to California's criminal justice system. The weakness of Proposition 36 is that in order to upgrade a theft charge to a felony, the thief must have been already been convicted twice of a theft crime. Even then, it requires a district attorney's willingness to charge a theft crime as a felony. Our own Contra Costa District Attorney, Diana Becton, has publicly stated that even if someone is caught stealing more than \$950 worth, but claimed they needed to steal to pay for necessities, she would not charge them with a felony.

Democrats would have us believe that these swarms of thieves are just poor people struggling to survive! When has "need" become a justification for criminality? Only in the minds of modern Democrats are laws to protect the public subject to an artificial needs test. The primary duty of good government is to protect people's rights and property. Allowing free-roaming criminality is the beginning of the end of a society. A final reason for the protection of the citizenry is that we do not want to be forced to resort to vigilante justice.

AN OPEN LETTER TO BOB IGAR, CEO OF THE WALT DISNEY COMPANY, OWNER OF ABC NETWORK

Dear Mr. Iger,



Let's look at the context of the Kimmel suspension. In 1963, the Communists' blueprint for the takeover of the United States was read into the Congressional Record. (You can still find it with a simple computer search.) It included things like infiltrate the press, get control of the schools, capture one or both political parties, transfer powers of arrest from the police to social agencies, and create the impression that violence and insurrection are legitimate aspects of the American tradition.

There is more, but I think you can see that much of their blueprint appears in today's headlines. Their plan is to destroy America by any means necessary, including lies, anarchy, and murder (doxxing, swatting, fomenting violence). REPUBLICAN CLUB OCTOBER MOVIE: "FLAGS OF OUR FATHERS"

The Republican Club will present the film "Flags of Our Fathers" in the Peacock Theater at 4:00 p.m. on Wednesday, October 15. Admission is free and everyone is invited!

"Flags of Our Fathers" is a 2006 war drama directed and co-produced by Clint Eastwood, starring Ryan Phillippe, Jesse Bradford, and Adam Beach. It tells the real life story of the six U.S. soldiers who raised the American flag on Iwo Jima and the iconic photograph of the flag raising that came to symbolize the determination and sacrifice of the Greatest Generation. The Battle of Iwo Jima, in 1945, was a major World War II confrontation in

which U.S. forces landed on and captured the island of Iwo Jima from the Imperial Japanese Army following a brutal five-week struggle. Eastwood shot "Flags of Our Fathers" as a companion piece to "Letters From Iwo Jima," another Eastwood film, which depicts the same battle from the Japanese perspective. ("Letters From Iwo Jima" was shown by the Republican Club in August.) Noted film critic Richard Roeper said: "Clint Eastwood's Flags of Our Fathers stands with the Oscar-winning Unforgiven and Million Dollar Baby as an American masterpiece."

ROSSMOOR GATE PROCEDURES FOR NON-ROSSMOOR RESIDENTS



THE TRUTH ABOUT HOW ASHLI BABBIT DIED

In June 2025 the U.S. Government entered into a \$4.975 million settlement of the wrongful death lawsuit filed on behalf of the family of Ashli Babbit, who was fatally shot by a Capitol police lieutenant during the January 6th U.S. Capitol riot. As stated by Tom Fitton, President of Judicial Watch, the conservative civil rights law firm that

represented Ashli's family: "This fair settlement is a historic and necessary step for justice for Ashli Babbitt's family. Ashli should never have been killed, and this settlement destroys the evil, partisan narrative that justified her outrageous killing and protected her killer." Fitton also praised the role of President Donald Trump in supporting justice for Ashli. "President Trump was an absolute rock in supporting Ashli's family and advocating for justice!"

Ashli was a 36-year-old Air Force veteran and small business owner from San Diego who traveled to Washington D.C. to attend the January 6th pro-Trump rally in the Ellipse park. Following the rally, Ashli was one of about 2,000 protesters who breached the U.S. Capitol that day. She was the only fatal casualty resulting from the January 6th Capitol protest. Ashli was shot and killed by Capitol Police Lt. Michael Byrd in the east entrance to the Speaker's Lobby. After protesters filled the hallway outside the lobby, two people in the crowded, tightly packed hallway struck and dislodged the glass panels in the lobby doors and right door sidelight. Ashli was shot by Byrd as she raised herself through the sidelight opening. She was unarmed, her hands were empty and in the air.

Following the shooting, Lt. Byrd was coddled and protected by the Biden administration. Lt. Byrd, along with his pet, was housed at taxpayer expense for 18 months at Joint Base Andrews in a lavish "Distinguished Visitor Suite," normally reserved for U.S. military generals. The Biden administration tried its best to keep Lt. Byrd's identity hidden from the public, but when that failed Lt. Byrd agreed to be interviewed on NBC News. During his interview, Byrd claimed he shot Ashli in "self defense" or defense of others, notwithstanding that he never saw any weapon in her possession. Byrd shot Ashli on sight, without calling out any warning or command.

As pointed out by noted constitutional law professor Jonathan Turley, U.S. Supreme Court decisions and nationally accepted law enforcement standards forbid police officers from shooting unarmed suspects or protesters absent any clear threat to themselves or other people. Notwithstanding Lt. Byrd's virtually admitted violation of that standard, he was never legally charged or otherwise punished or disciplined for slaying Ashli. Under prevailing legal standards Byrd should have been indicted and put on trial for murder or manslaughter. Instead, Byrd was given a pass by Joe Biden's Department of Justice, led by Attorney General Merrick Garland. Garland's Justice Department conducted a low-profile internal investigation and ruled that Byrd had "acted lawfully" and within department policy when he shot the unarmed Ashli Babbit on sight and without warning. As compared to other high-profile cases involving unarmed civilians slain by police officers—such as George Floyd, Oscar Grant, and Michael Brown—the mainstream media paid virtually no attention to Ashli's death and the issue of Lt. Byrd's culpability.

So why was Lt. Byrd so closely protected by the Biden administration and Democrat media allies? The answer involves two propaganda narratives that are vital to Democrat Party political strategy and leftwing ideology. The first narrative is the leftwing mythology surrounding the January 6th Capitol riot. Democrats and their friends in the media have made a fetish of casting that event in overwrought and apocalyptical terms, labeling it as an "insurrection" and "threat to democracy." Vice President Kamala Harris, in a speech delivered on January 6, 2022, actually compared the Capitol riot to the al-Qaeda terrorist attack of September 11, 2001 (which resulted in 2,977 deaths and brought about the U.S. war in Afghanistan) and the Japanese attack on Pearl Harbor (which resulted in 2,335 American deaths, four U.S. battleships sunk, and U.S. entry into World War II). Democrats and the media even tried to connect several deaths from suicides and natural causes to the January 6th riot. However, Merrick Garland's Justice Department—despite charging over 1,500 people with January 6th-related crimes and conducting the most aggressive and wide-ranging mass prosecution in American history—never charged any January 6th defendant with a homicide-related

offense—which would have required prosecutors to actually prove causation of death in a court of law. Nor was any January 6th defendant ever charged with "insurrection," which is a federal crime set forth in 18 U.S.C. § 2383, defining armed rebellion against the U.S. government.

So how should the January 6th Capital invasion properly be described? Perhaps some perspective can be gleaned by comparing the violence that broke out in the wake of the May 2020 killing of George Floyd. Riots carried out by violent left-wing activists in response to Floyd's killing resulted in 25 violent deaths, two billion dollars in property damage, and 14,000 arrests for crimes including aggravated assault, property destruction and looting. Police officers were physically assaulted and shot, local businesses were looted and wrecked, and ordinary citizens were terrorized. Nonetheless, the media often charactered the left-wing gatherings leading up to this destructive violence as "mostly peaceful protests"—never as "insurrections." Honest journalism would classify January 6th and the outbreaks of violence carried out by the George Floyd protesters equally as "riots." But allowing the public to focus on the reality that the sole fatal casualty of the January 6th Capitol riot was an unarmed white woman shot dead by a reckless cop would have done much to dispel the apocalyptic "insurrection" propaganda narrative upon which Kamala Harris and fellow Democrats banked so much of their 2024 election capital.

The fact that Alshli was a white woman and Lt. Byrd was a black policeman undercut a second leftwing propaganda narrative vital to Democrat political strategy: the alleged existence of an "epidemic" of unarmed black men being slaughtered by racist white cops as a consequence of "systemic racism" in America. Acceptance of that narrative bolsters Democrat election support—particularly following the death of George Floyd—by way of black voters being led to believe that Democrat politicians will protect them by restraining cops and defunding police departments and white voters hooked in by a combination of white guilt and moral vanity. This narrative is another Democrat lie: there is no "epidemic" of unarmed black men being slain by police. An analysis by the Washington Post following George Floyd's death showed 14 unarmed black victims and 25 unarmed white victims of police shootings in 2019. In fact, a police officer's chance of getting killed by a black assailant is 18.5 times higher than the chance of an unarmed black person getting killed by a cop. Nonetheless, a recent Manhattan Institute paper reported that some 80% of black Americans and half of white Joe Biden voters believed the falsehood that "black men were more likely to be shot to death by police than to die in a car accident." In fact, the reality is that black men between the ages of 18 and 34 are more than 17 times more likely to die in motor-vehicle accidents (38.4 deaths per 100,000) than to be shot to death by police (2.2 per 100,000). Democrat politicians who benefit from this false racial narrative certainly don't want to see it undermined by any media attention focused upon an unarmed white woman (Ashli Babbit) being gunned down by a trigger-happy black cop (Lt. Byrd).

For Democrat politicians and their media allies to sustain their false narratives about a January 6th "insurrection" and an "epidemic" of police slayings of unarmed black men they have to do their best to prevent Americans from learning the truth about Ashli Babbit.
