JEAN FOLLMER, MEMBER OF THE CONTRA COSTA GOP CENTRAL COMMITTEE AND FORMER LAFAYETTE SCHOOL BOARD MEMBER, WILL SPEAK AT OUR AUGUST 19 DINNER

Jean Follmer, Contra Costa GOP Central Committee Member and former member of the Lafayette School Board, will talk about "Politics and Education" at our Republican Club dinner on August 19, at 5:15 pm in the Event Center's Tahoe Room.

Jean is a Chicago native who first moved to San Francisco in 1993. Her family left California in 1997, but in 2007 Jean and her husband returned to the Bay Area and moved to Lafayette with their two children. Since then, Jean has been deeply involved in the Lamorinda community. Jean has served on the Lafayette Community Foundation, Orinda Aquatics, Springhill Parent Faculty Club, and Lafayette Partners in Education boards. She also co-founded the grassroots community group Lafayette for Education. Jean worked as a reporter for the Lamorinda Weekly from 2007 to 2011 and chaired the non-partisan Children's PAC from 2015 to 2017. Jean's most notable community involvement was serving on the Lafayette School Board. She was first elected to the board in 2012 and served two terms, from 2012 to 2016 and 2018 to 2022, including a term as School Board President. Jean's duties included planning and conducting annual and mid-year Superintendent reviews, presiding over public meetings, participating in board and committee meetings, working toward a sound and responsible budget, union negotiations, benefits overhaul, legislative activism, communications, curriculum, and traffic and safety.

Jean is currently a member of the Contra Costa Republican Central Committee, where she has served as District 2 Chair, District Caucus Chair, and Election Integrity Officer. Jean's objective on the Central Committee is to recruit, support, and elect fiscally disciplined conservatives to run for local non-partisan school boards and city councils and serve on local commissions.

"PAY YOUR FAIR SHARE!"

A favorite slogan of the left is "The Rich Should Pay Their Fair Share"—to which I must agree! The top 1% of income earners currently account for the payment of 40% of all federal income taxes. The top 25% pay 87% of federal income taxes. The bottom 50% account for only about 3%. Many of those in the bottom half actually receive a welfare payment exceeding their tax payment, known as the "Earned Income Tax Credit." Obviously, this allocation of the tax burden hardly amounts to a "fair share" distribution. In order for the "rich" to actually pay their "fair share" it would be necessary to significantly reduce the top marginal tax rates. Of course, this is nothing like what the left has in mind.

Aside from the injustice and un-American nature of income redistribution, government policies along those lines serve to destroy any incentive to be productive. The reality is that people are motivated to sacrifice and invest for the benefit of their future and that of their family—not for any nebulous "common good."

Socialism always fails. First, because within a Socialist system there are no personal incentives to work, strive, and innovate. And second, because substituting government regulation-based management for private, profit-motivated ownership and allocation of capital is invariably a recipe for failure.

The Republican Club will present the film "Letters From Iwo Jima" in the Peacock Theater at 4:00 p.m. on Wednesday, August 20. Admission is free and everyone is invited!

"Letters From Iwo Jima" is a 2006 Japanese-language American war movie directed and co-produced by Clint Eastwood. It stars Ken Watanabe and Kazunari Ninomiya. The film portrays the historic Battle of Iwo Jima from the perspective of the Japanese soldiers who fought and died there. Eastwood shot "Letters From Iwo Jima" as a companion piece to

"Flags of Our Fathers," another Eastwood film, which depicts the same battle from the U.S. perspective. The Battle of Iwo Jima, in 1945, was a major World War II confrontation in which U.S. forces landed on and ultimately captured the island of Iwo Jima from the Imperial Japanese Army, following a brutal five-week struggle. Several prominent film critics—including Lisa Schwarzbaum of Entertainment Weekly, Kenneth Turan of the LA Times, and Richard Schickel of Time magazine—named "Letters From Iwo Jima" as their personal best picture of 2006!



TRUMP ADMINISTRATION SANCTIONS NOTORIOUS U.N. ANTI-SEMITE

On July 9, the Trump administration sanctioned U.N. Human Rights Special Rapporteur Francesca Albanese. Secretary of State Marco Rubio explained that sanctions were imposed due to Albanese's involvement in a "campaign of political and economic warfare against the United States and Israel" and her "illegitimate and shameful efforts to

prompt [International Criminal Court aka "ICC"] action against U.S. and Israeli officials, companies and executives." Rubio emphasized that Albanese had directly engaged with the ICC "in efforts to investigate, arrest, detain, or prosecute" Americans and Israelis, even though neither country is a signatory to the Rome Statute, which established the ICC and precludes its jurisdiction over non-signatory nations. Rubio stated: "Albanese's campaign of political and economic warfare against the United States and Israel will no longer be tolerated." The U.S. sanctions are likely to prevent Albanese from traveling to the U.S. and to block any assets she holds in this country.

Albanese is an Italian academic who studied law at the University of Pisa and holds a Master of Laws in human rights from The School of Oriental and African Studies of London. In May 2022, she was appointed United Nations Special Rapporteur on the Palestinian territories for a three-year term, which was then renewed for another three years. (A Special Rapporteur is a human rights expert appointed by the U.N. to advise regarding a particular locale.) Notwithstanding her lofty academic credentials and impressive sounding job title, Albanese has racked up an extensive record as an anti-American and Jew-baiter.

As Special Rapporteur, Albanese has advised the International Criminal Court to issue arrest warrants for Israeli Prime Minister Benjamin Netanyahu and ex-Defense Minister Yoav Gallant. Albanese has called for a worldwide boycott of Jewish businesses and has advocated that the ICC prosecute corporations that are "profiting" from "Israel's settler-colonial project." Albanese has publicly justified Hamas murderous terrorist violence against Israeli civilians. She has even recommended that Israel be stripped of its U.N. membership. She has labeled Donald Trump and Winston Churchill as "white supremacists" and has attacked the U.S. as being "subjugated by the Jewish lobby." She says that in the United States "the Israel lobby has bought and paid for Congress and the two ruling parties, as well as cowed the media and universities." In 2015 she spread a crackpot conspiracy theory blaming the U.S. CIA and the Israeli Mossad for the 2015 terrorist attack by ISIS that massacred Charlie Hebdo journalists in Paris.

One of Albanese's favorite pastimes is accusing Israel of "genocide" and equating Israel to Nazi Germany, which brutally murdered 6 million Jews. Albanese has repeatedly compared Israel's defensive actions in Gaza to the Holocaust. In July 2024, Albanese reposted an image equating Israeli Prime Minister Benjamin Netanyahu with Adolf Hitler, while commenting: "This is precisely what I was thinking today." In February 2025, Albanese wrote that "it is about time that Israel and the U.S.—and those who enabled and armed the genocidal assault against the Palestinians—make plans to offer REPARATIONS to the Palestinian people to rebuild Gaza."

In an April 2025 speech, Albanese called America "a nation founded upon genocide." In a May 2025 interview, Albanese claimed that the Trump administration is "wildly and fastly contributing to the dismantlement of the world order that was established after World War II, in the sense it is acting manifestly above and against the law" and advocated that "all the other members of the United Nations stand united against this. It's really the united people of the world against the government of the United States of America." Following President Trump's successful strike against Iran's nuclear facilities on June 22, 2025, Albanese said "it is still not too late for the 191 other UN Member States to act" and "stand FIRM against rapacious lawlessness" by the U.S.

These are outrageous lies and distortions of moral reality. The Jews of Israel are not "settler colonialists." Jews have maintained a continued presence in the Middle East since Biblical times—not only within the boundaries of present-day Israel, but also in nearby lands. In the aftermath of the 1948 Arab-Israeli War, over 850,000 Jews were forced to leave or flee from their homes in various Muslim countries, including

Egypt, Syria, Iraq, Lebanon, and Libya. If anything, based upon their historic presence, Jews should fairly be entitled to a greater percentage of Middle Eastern land than the 1/10 of 1% occupied by modern-day Israel. Israel is certainly not committing or attempting to commit "genocide"—meaning deliberately acting for the purpose of destroying a national, ethnic, racial, or religious group, as was the case with the Nazi imprisonment and murder of defenseless Jews who had never attacked Germany or did it any harm. The reality is that Israel is fighting a defensive war of survival against aligned forces—by way of Iran, Hamas, the Houtis, and Hezbollah—who are bent on destroying it and killing as many Israeli Jews as possible. The present Israeli-Gaza war began with the October 7, 2023 sneak attack by Hamas in which 1,200 Israelis were murdered, 250 were taken hostage, and many others were raped and brutalized. Israel is no more guilty of "genocide" then the allied forces who invaded and occupied the Nazi capital during the 1945 Battle of Berlin, leaving 150,000 dead German civilians in their wake. The U.S.—and the Trump administration in particular—do not support Israel because they have been "bought and paid for" or "subjugated by the Jewish lobby," as Albanese slanderously claims. The Trump administration supports Israel against its sworn enemies because it is the ethically and morally right thing to do.

Albanese's behavior is so outrageous that even President Biden's administration denounced her U.N. appointment. In 2024, then-U.S. Ambassador to the U.N. Linda Thomas-Greenfield declared that Albanese is "unfit for her role" at the U.N. and that "the United Nations should not tolerate antisemitism from a UN-affiliated official hired to promote human rights." French and German U.N. ambassadors also expressed their strong disapproval at Albanese's anti-Semitic statements in the wake of Hamas' October 7 murderous attack on Israel. However—unlike those other governments—President Trump is not just talking, he is actually doing something about Albanese's despicable Jew-baiting and he is to be commended for it.

No one should be mesmerized by Albanese's academic and legal credentials. It should be recalled that Nazi Minister of Propaganda Joseph Goebbels possessed a PhD in literature and history from the prestigious University of Heidelberg. Hans Frank, a prominent German lawyer and jurist, was found guilty at the first Nuremberg Trial and sentenced to death for war crimes and crimes against humanity, particularly with regard to his involvement in the extermination of European Jews.

The U.N.'s embrace of this unvarnished Jew-hater is no outlier. It's merely the latest chapter in the U.N.'s long and sordid history of anti-Semitism, double standards, and hypocrisy when it comes to the small democratic State of Israel. Critics of President Trump's sanctions on Albanese complain that the U.S. is somehow undermining the legitimacy of the U.N. and the international order that the U.N. is supposed to represent. Typical is Amnesty International head Agnes Callamard, who said: "Governments around the world and all actors who believe in the rule-based order and international law must do everything in their power to mitigate and block the effect of the sanctions against Francesca Albanese." Apparently, it doesn't faze the likes of Callamard that Special Rapporteur Albanese has worked endlessly to delegitimize—if not destroy—the State of Israel, the only Jewish-majority nation in the world, by advocating that its president be tossed in jail for the "crime" of defending his people from being slaughtered, that Israel be economically destroyed by means of worldwide economic boycotts, and that Israel even be stripped of its U.N. membership. The reality is that it isn't the Trump Administration that is delegitimizing the U.N. by sanctioning Albanese. It is the U.N. which has seriously undermined its very own moral legitimacy by bestowing a position of high moral prestige and influence upon someone who would be more at home at a National Socialist Party beer hall rally in Munich, in 1923, then as a high official in an international organization which pretends to aspire to lofty humanitarian aims.

Upon being sanctioned by the U.S., Albanese arrogantly proclaimed: "Just to be sure, on this day more than ever: I stand firmly and convincingly on the side of justice, as I have always done. I come from a country with a tradition of illustrious legal scholars, talented lawyers and courageous judges who have defended justice at great cost and often with their own life. I intend to honor that tradition. Also: it is called the Rome Statute [creating the International Criminal Court] for a reason, and I am proud of it." Actually, it should be recalled that Italy—Albanese's native country—was the closest ally of Adolph Hitler's Germany and a participant in the actual Holocaust, sending thousands of Italian Jews to concentration camps and their deaths. That is, in fact, the national legacy that this unrepentant Jew-baiter is carrying on.

SECOND AMENDMENT UPDATE By Bill McConnell, Ph.D.

We Second Amendment advocates should be celebrating all the pro-gun actions happening at the national level and in the various states. Here is just a sample of the some of the things that we can be thankful for:



- The Dickey Amendment, the federal law which shields gun manufacturers from frivolous lawsuits, remains in place in spite of fervid efforts by gun-banners to rescind it.
- President Trump reinforced Centers for Disease Control rules prohibiting biased research that "looks for" justifications to expand "gun control."
- President Trump cut the current ATF budget of \$1.62 billion by \$468 million. This will reduce harassment of manufacturers, gun dealers, and gun owners.
- Attorney General Pam Bondi has created a Second Amendment Task Force to help everyone remember that the Second Amendment protects a basic American right—not a privilege.
- Harmeet Dhillon, a tireless warrior for civil rights, including gun rights, was appointed by President Trump as Assistant Attorney for Civil Rights.
- States are also stepping up to protect the Second Amendment:
 - Montana: Prohibits local Red Flag laws that permit police seizure of firearms with minimal due process.
 - Oklahoma: Prohibits public entities from contracting with businesses unless they certify that they do not discriminate against firearm companies.
 - Tennessee: Reduces concealed carry age and protects manufacturers against frivolous lawsuits.
