#### **Our Cost**

- **\$4500** per student
- Payment Plan: Tuition is divided into 10 equal payments with the first payment due June 30th of the current school year.

# Health-Related Admissions Requirements & Emergency Contacts for Haddon Heights Christian school

The parent/guardian of a child entering Haddon Heights Christian School must present an updated copy of the child's immunization record along with the Private Physician Examination Report. These 2 items must be presented to the Administrator prior to attending the first day of school.

Although the state of New Jersey requires certain vaccinations for school aged children, Haddon Heights Christian School will accept Medical and/or Religious Exemptions. If your family has a Medical and/or Religious Exemption for childhood vaccinations, please submit your exemption in writing along with your admissions application.

#### **HHCS Wellness Policy**

Haddon Heights Christian School does **not** require face masks or Covid vaccination. However, In our effort to keep one another safe and healthy, we ask that you keep your child at home if he/she isn't feeling well.

**ISOLATION:** If your child has a fever, keep them at home until:

- They are fever-free for 24 hours (without the use of fever reducing medication)
- Their symptoms are improving

If your child is ill, we ask that you provide Haddon Heights Christian School with updates on your child's healing process. We will be praying for a quick and complete recovery.

#### **Parent/School Agreement**

Children must be accepted to Haddon Heights Christian School through a formal admissions process. Both parental involvement and student cooperation are essential for HHCS to fulfill its mission. Therefore, as a condition of acceptance to this school, the parents and student(s) applying for admission must fulfill the following requirements:

- Parents must provide HHCS with a completed application form for each child applying for admission, including academic records, health forms, and other information as specified in the application packet. Students will not be admitted without complete records.
- Parents and students must sign a form stating their acknowledgement of our Statement of Faith as an expression of who we are and what will be taught in the classroom.
- Parents and students must be willing to abide by the school's rules and regulations as expressed in the handbook or by the administrator and must agree with and be supportive of the school procedures for handling student discipline.
- Parents must be willing to have student pictures in the school yearbook.

Parents and students will be held accountable for their words and actions, particularly with communication between home and school. Humility, gentleness, and spiritual maturity should be displayed in treating the staff, faculty, and students at Haddon Heights Christian School. Mutual respect, both publicly and privately, are essential. If a parent or student speaks unkindly or disrespectfully to any faculty, staff member, or student, the matter will be taken up with the administrator, who will, according to biblical instruction, give the offending party an opportunity to repent and ask forgiveness of the offended party. If there is an unwillingness to comply with the guidelines that have been established, the student(s) of that parent or parents may be withdrawn from the school, or not permitted to return for the following year.

In enrolling one or more of our children in Haddon Heights Christian School, a school which affirms the responsibility of parents for the education of their children, we acknowledge and accept primary responsibility of our children's behavior at school. We also acknowledge that we are responsible for being familiar with and will consult the policies of the school as published in the Handbook. When making decisions affecting our relationship or our child(ren)'s relationship with the school, we will accept full responsibility for the results of our decisions.

#### **Haddon Heights Christian School Statement of Faith**

Haddon Heights Christian School is a ministry of Haddon Heights Baptist Church. HHBC is an evangelical church associated with the General Association of Regular Baptists (GARBC), and we subscribe to the statements contained in the Articles of Faith. Our core beliefs can be summarized below. We believe:

- the Bible is the verbally inspired Word of God and without mistakes as originally written. It is the complete revelation of His will for salvation and the only unfailing rule of faith and practice for the Christian life.
- in one God, Creator of all things, eternally existing in three persons: Father, Son and Holy Spirit, and that these three are co-eternal and of equal dignity and power.
- in the deity of Jesus Christ; His miraculous conception by the Holy Spirit; His virgin birth; His sinless life; His substitutionary death on a cross; His bodily resurrection; His ascension to the right hand of the Father; and His personal, imminent return.
- that man was created by and for God; that by man's disobeying God, every person incurred spiritual death, which is separation from God, and physical death as a consequence; and that all people are sinners by nature and practice.
- the Bible teaches that marriage is the joining of one man and one woman and that sexual intimacy is to be expressed only within the bonds of a Biblically defined marriage. Any other form of marriage or sexual intimacy is immoral and a perversion of God's gracious will.
- the Lord Jesus Christ died for our sins and that all who believe in Him are declared righteous because of His sacrificial death and are, therefore, in the right relationship with God.
- in the present ministry of the Holy Spirit indwelling all believers and thus enabling and empowering the life and ministry of the believer.
- in the Church which is the Body of Christ made up of all those who have believed in the Lord Jesus Christ for salvation.
- in the bodily resurrection of everyone who has lived, the everlasting blessedness of those in right relationship with God, and the everlasting punishment of those who have rejected God's forgiveness in His Son.
- HHCS affirms one's biological gender as created by God in His image. HHCS believes in the dignity of
  the distinction of genders. Individuals will be referred to by appropriate biological pronoun
  distinction. HHCS discourages any and all attempts to physically change, alter or disagree with the
  predominant biological gender (sex), including but not limited to sex- reassignment, gender identity
  disorder, and any other behaviors that do not affirm one's God-given gender. Genesis 1:26-28;
