

Application Process for Put on the Cape Causeplay

PLEASE READ THIS DOCUMENT IN ITS ENTIRETY

MEMORANDIUM OF UNDERSTANDING (MOU)

- (1.) Put on the Cape a Foundation for Hope (POTC) has exempt status under the IRS code (501c3) for purposes of taxation.
- (2.) Put on the Cape Cause Play (POTCCP) is directly attached to POTC. Members of POTCCP administration are considered "Leadership" under IRS federal code.
- (3.) Under the Internal Revenue Service Code, all section 501(c) organization leadership are absolutely prohibited from directly or indirectly participating in, or intervening in, any political campaign on behalf of (or in opposition to) any candidate for elective public office.
- (4.) Discrimination based on gender, color, creed, religion, and sexual orientation, is unacceptable and prohibited by federal law.
- (5.) Sexual harassment, be it unwanted comments or touch, is UNACCEPTABLE and any instance of such is a reportable offense to be investigated by the compliance committee of POTC. If the member is found to have violated this clause, your membership in POTCCP is revoked.
- (6.) POTC founder Sean Reavie is a highly decorated veteran law enforcement officer. The largest donor/contributor to POTC is a law enforcement union. POTC supports 15 law enforcement department's Crimes Against Children investigative teams and task forces. As such, any anti police rhetoric or PUBLIC support of anti-law enforcement groups is grounds for dismissal from this group. We are not asking fealty to law enforcement. We are asking for personal feelings toward law enforcement (positive or not) be tempered as to not be associated with our mission of healing and hope.
- (7.) All members (within 6 months of membership) obtain basic fingerprint clearance (\$20 to paid for by POTC toward the clearance card) to be in federal compliance with organizations involved in working indirectly or directly, with physically and sexually abused children. Level One Clearance, which is good for six years, can be used with any organization. This is another option to be paid for by the member.
- (8.) All Members (within 6 months) be trained in ACES (Adverse Childhood Experiences) to better understand the children we are helping, and the tasks of the people involved in helping them.
- (9.) All members attending our events, must maintain a professional impression, sensitivity, and dignity associated with those who work with critically abused children.
- (10.) All members (within one year of membership) tour a Family or Child Advocacy Center in their area to see first-hand how these centers work. It is our mission to provide for these centers. POTC Founder Sean can assist you with this. Contact him for the nearest center to you.

Our POTC Signature event series raises monetary and in-kind donations for Child Advocacy Centers to ensure the child victims are given food, clothing, and a toy when they are at the center.

Regarding fingerprint clearance: All applicants MUST obtain fingerprint clearance and be free of any charges that rise to the level of a felony. POTC will help defer the cost of this service and a background check is to be conducted on each member from a public record database. If someone is not fingerprint cleared, they cannot work with victims of crime. If there are any incidents in your past, we are happy to speak to you about them. If they are not disclosed and later turn up on a background check, your application request will not be granted.

There exists a ZERO TOLERANCE policy in regard to sexual harassment. Violations are to be reported to administration immediately for investigation. If evidence exists of the harassment, the member is to be expelled from our organization. Cosplay does NOT equal consent.

All religions, orientations, creeds, and views are embraced. There exists a ZERO TOLERANCE policy in regard to anyone who discriminates against a fellow member.
