If legal or other requirements mean you must buy any items you did not specifically asked for, we will explain the reason in writing on the statement we provide describing the goods and services you selected.

You will be charged for only the items you select. Please note that there may be extra charges for items such as cemetery fees, medical examiner authorization fees, processional escorts, cremation caskets or alternative containers, death certificates, newspaper notices, or for items and services provided by another funeral home, or other death care industry business if those services are not purchased from Aikens Funeral Home.

Itemized Services of Funeral Director and Staff

Basic Services of Funeral Director and Staff and Overhead.....\$2,000.00

Our services include: conducting the arrangements conference; planning the service; consulting with family and clergy; shelter of remains; preparing and filing of necessary documents and notices; obtaining necessary authorizations and permits; coordination with cemeteries, crematories, or other third party entities. In addition, this fee includes proportionate share of our basic overhead costs. This fee for our basic services and overhead will be added to the total cost of the arrangements you select.

Basic Services of Funeral Director and Staff and Overhead for Direct Cremation, Immediate Burial, Forwarding Remains To Another Funeral Home, Repatriation/Transfer of Remains, Receiving Remains From Another Funeral Home, Anatomical Donation.....\$1,095.00

Our services include: conducting the arrangements conference and consulting with the person directing disposition; preparing and filing of necessary documents and notices; obtaining necessary authorizations and permits; coordination with cemeteries, crematories, or other third party entities. In addition, this fee includes proportionate share of our basic overhead costs. This fee for our basic services and overhead will be added to the total cost of the arrangements you select.

Preparation of the Deceased

Except in certain cases, embalming is NOT required by law. Embalming may be necessary, however, if you select certain arrangements, such as services with a public viewing before burial or cremation. If you do not want embalming, you usually have the right to choose an arrangement, such as direct cremation or immediate burial, that does not require you to pay for it.

"A dead human body may not be held in any place or in transit over 24 hours after death or pending final disposition unless maintained under refrigeration at a temperature of 40 degrees Fahrenheit or below or is embalmed or otherwise presented in a manner approved by the state licensing authority." Florida Statue 497.386 (2) - Storage, preservation, and transportation of human remains.

Forwarding of Remains to Another Funeral Home (Within Continental United States).....\$2,865.00

Our charge includes transfer of remains to funeral home, basic services of funeral director and staff, all necessary preparation of remains, undergarments, including unionalls, private family viewing, shipping container (not a casket), or air tray and local ground transportation to common carrier. This cost does not include any services of staff or use of facilities for public viewing or for a funeral ceremony prior to forwarding of remains. Likewise, this cost does not include any shipping charges or ground transportation of remains outside local 35 mile radius.

Note: Add \$4.00 per mile (one way) for ground transportation of remains in excess of local 35 miles radius.

Forwarding of Remains Anatomical Donation.....\$2,650.00

Our charge includes transfer of remains to funeral home, basic services of funeral director and staff, all necessary preparation of remains, undergarments, including unionalls, private family viewing, and local ground transportation to the institution of choice. This cost does not include medical examiner's fee, any additional services of staff, use of facilities for public viewing or for a funeral ceremony, or for ground transportation of remains outside local 35 mile radius.

Note: Add \$4.00 per mile (one way) for ground transportation of remains in excess of local 35 miles radius.

Repatriation/Forwarding of Remains to Another Funeral Home (Outside Continental United States).....\$4,315.00

Our charge includes transfer of remains to funeral home, all necessary preparation of remains, undergarments including unionalls, all related domestic logistics, acquisition, translation and completion of all consulate documentation, apostille certification, and other documentation required by the receiving country, a private family viewing, applicable shipping container (not a casket), or air tray and local ground transportation to common carrier. This cost does not include a sealed casket, any services of staff or use of facilities for public viewing or for a funeral ceremony prior to forwarding of remains. Likewise, this cost does not include any shipping charges, airline fees or ground transportation of remains outside local 35 mile radius.

Note: Add \$4.00 per mile (one way) for ground transportation of remains in excess of local 35 miles radius.

Receiving Remains from Another Funeral Home.....\$3,830.00

Our charge includes all local transportation for the remains, basic services of funeral director and staff, other preparation of the remains, use of facilities and staff for viewing and for the funeral ceremony. This cost does not include any merchandise or cemetery charges. This charge does not include any transportation for the family or ground transportation of remains outside local 35 mile radius.

Note: Add \$4.00 per mile (one way) for ground transportation of remains in excess of local 35 miles radius.

Receiving Remains/Graveside Services with No Visitation.....\$2,545.00

Our charge includes all local transportation for the remains, basic services of funeral director and staff and other preparation of the remains. This cost does not include any merchandise or cemetery charges. Likewise, this charge does not include any transportation for the family.

Immediate Burial.....\$2,250.00

Our charge for an immediate burial (without ceremony) includes transfer of remains, basic services of funeral director and staff, use of refrigeration facility, and local transportation to cemetery. This cost does not include embalming, a casket, services of staff or use of facilities for viewing or funeral ceremony, cemetery charges or any merchandise.

Immediate burial with casket.....\$3,550 to \$44,500.00

Direct Cremation.....\$4,070.00

Our charge for a direct cremation (without ceremony) includes all local transportation of remains, refrigeration up to seven (7) days, basic services of the funeral director and staff, private family viewing, the cremation process and a basic urn. It does not include embalming, or other preparation of the remains, medical examiner fees, cremation casket, alternative cremation container, or any other merchandise. The use of a cremation casket or alternative cremation container for direct cremation is required by law. The alternative containers we offer will encase the body and are made of materials like cardboard or wood composite. material.

Payment Options and Policies

It is our highest aim that we satisfy all our families with a memorable tribute. At the time of arrangements we will need to secure a guarantee of payment prior to any services being scheduled. **Full payment must be received or insurance verified four (4) days prior to any service being conducted.** We accept Cash, most major Credit Cards, Cashiers Check or other approved financing. **A 3% Credit Card Processing Fee (third party vendor) will be applied to all credit card payments. A 4% insurance filing fee (third party vendor) will be applied to all insurance assignments.** This filing fee is applied to the funeral contract and the funeral home will wait for insurance reimbursement and pay all other entities on behalf of the client-family prior to services being rendered. **Due to the complexity and time involved we are unable to accept payments from estates, 401 (K) plans or any insurance policies effective less than 2 years from date of death.**
