# ROBESON TOWNSHIP BOARD OF SUPERVISORS WORKSHOP MEETING MINUTES April 13, 2023

The Workshop Meeting of the Robeson Township Board of Supervisors was held at the Municipal Building, 2689 Main Street, Birdsboro PA on Thursday, April 13, 2023. The meeting was called to order at 7:00pm by Chairman Christopher M. Smith. Present for the meeting were Vice-Chairman Galen L. Brown, Supervisor Jeffrey Rhoads, Supervisor Timothy B. Bitler, and Supervisor Harold W. Steve, Jr. Also present were Solicitor Eugene Orlando, Jr., Robeson Township Police Chief Dennis W. Cassel, Jr., Township Manager Richard L. Orwig, and Fiscal Assistant Shelia McCune via zoom.

## Citizen Concerns / Public Comment:

Bernard C. Keturakis II – expressed concern over road condition on Bard Road.

Trinity Drilling and Explosives – Representatives of Trinity Drilling, Keith Brubacker, Lonny Horst, and James Strong, Esq. appeared before the Board to explain the proposed magazine storage site on the Hertzler Farm. Attorney Strong suggested that the proposed use is not identified in the AP zoning district nor permitted anywhere in the Township, he suggested amending the Zoning Ordinance to allow the use in the AP zoning district. Mr. Brubaker gave an overview of how the site would be designed and operated. Trinity is seeking a long-term lease on the Hertzler Farm consisting of approximately three (3) acres. Supervisor Bitler inquired as to the type and extent of insurance that would cover the project. Supervisor Steve and Vice-Chairman Brown question what type of security would be provided. Chairman Smith asked about the amount of truck traffic that would be anticipated on a daily basis. Supervisor Rhoads questioned the traffic patterns that would be travelled and what emergency plans would be in place for fire protection. Supervisor Steve questioned what types of explosives would be stored at the facility. Solicitor Orlando suggested that an escrow account be established to cover Township expenses. Chief Cassel suggested that in the event of any type of incident that the Police Department should be first to be notified. Supervisor Bitler suggested that Attorney Strong draft a proposed zoning amendment for the Board to review. No further action taken at this time.

Paint the Town Purple 5K Race – Lynn Cronomiz and Catherine McCarthy of the Alzheimer's Association explained the proposed 5k Race to start at Joanna Furnace from approximately 9:30am – 11am on Saturday June 17<sup>th</sup>. Chief Cassel stated that he will coordinate the closing of affected roads. Ms. Cronomiz will be responsible for notifying homeowners located along the racecourse.
