A RESOLUTION OF ROBESON TOWNSHIP, BERKS COUNTY, COMMONWEALTH OF
PENNSYLVANIA, APPOINTING TAXPAYERS TO SERVE ON THE GEIGERTOWN AREA
JOINT AUTHORITY

WHEREAS, the Township of Robeson did, pursuant to the Municipal Authority Act of 1945, P.L., 382 as amended, create the Robeson Township Municipal Authority by Ordinance 85-01 dated May 08, 1985; and enacted March 12, 1985.

WHEREAS, as the incorporating governmental unit the Robeson Township Board of Supervisors are required to appoint members to the Geigertown Area Joint Authority.

WHEREAS, Margaret Maclean (Joint Citizen Appointment) was appointed to the vacant position in Robeson Township;

WHEREAS, the Board of Supervisors of the Township of Robeson desires to appoint Nelson Ott, Jr., to the Joint Citizen Appointment.

NOW THEREFORE, BE IT RESOLVED, AND IT IS HEREBY RESOLVED that the Board of Supervisors of the Township of Robeson hereby appoint Nelson Ott, Jr. to serve as a member of the Geigertown Area Joint Authority with the remaining term of Margaret MacLean to expire 12/31/2026.

FURTHER RESOLVED, that if any provision, sentence, clause, section, or part of this Resolution shall for any reason be found to be unconstitutional, illegal, or invalid, such determination shall not affect or impair any of the remaining provisions, sentences, clauses, sections, or parts of this Resolution, and it is hereby declared to be the intent of the Board of Supervisors of Robeson Township that this Resolution would have been adopted had such unconstitutional, illegal, or invalid provision, sentence, clause, section, or part not been included herein.


FURTHER RESOLVED, all Resolutions or parts of Resolutions inconsistent with this Resolution are hereby superseded.

FURTHER RESOLVED, that this Resolution shall become effective immediately.


