

# ROBESON TOWNSHIP, BERKS COUNTY, PENNSYLVANIA

## RESOLUTION NO. 2026-02

### **A RESOLUTION APPOINTING ZELENKOFKSKE AXELROD, LLC, CERTIFIED PUBLIC ACCOUNTANTS TO MAKE AN EXAMINATION OF ALL ACCOUNTS OF THE TOWNSHIP FOR FISCAL YEAR 2025.**

**WHEREAS**, pursuant to Section 917(b) of the Second Class Township Code, as amended, the Board of Supervisors of the Township of Robeson, Berks County, Pennsylvania, are authorized at their annual reorganization meeting to appoint by resolution a certified or competent public accountant or a firm of certified or competent public accountants, which shall be registered in the Commonwealth of Pennsylvania, to make an examination of all accounts of the Township for the next fiscal year stated in the Resolution, and to determine the compensation of the appointed accountant; and

**WHEREAS**, this Resolution is being considered for adoption at the 2026 Annual Reorganization Meeting of the Board of Supervisors of the Township of Robeson, Berks County, Pennsylvania, held on January 5, 2026; and

**WHEREAS**, the Board of Supervisors of the Township of Robeson, Berks County, Pennsylvania, are desirous of exercising the aforesaid authority under Section 917 of the Second-Class Township Code, as amended;

**NOW, THEREFORE**, the Board of Supervisors of the Township of Robeson, Berks County, Pennsylvania, hereby resolves as follows:

**THAT** Zelenkofske Axelrod, LLC, Certified Public Accountant registered in the Commonwealth of Pennsylvania, is hereby appointed to make an examination of the following for

fiscal year 2025:

- (1) all accounts of the Township of Robeson, Berks County, Pennsylvania;
- (2) all accounts of the Robeson Township Municipal Authority, Berks County, Pennsylvania; and
- (3) all accounts of the Tax Collector of the Township of Robeson, Berks County, Pennsylvania, and shall be paid the following compensation for the performance of said duties:

(1) up to **Fourteen Thousand Seven Hundred Dollars (\$14,700.00)** for the accounts of the Township of Robeson;

(2) up to **Nine Thousand One Hundred Dollars (\$9,100.00)** for the accounts of the Robeson Township Municipal Authority; and

(3) up to **Four Thousand Six Hundred Dollars (\$4,600.00)** for the accounts of the Tax Collector of the Township of Robeson.

**THAT** any prior Resolution of this Board inconsistent with this Resolution is hereby repealed.

**ADOPTED** by the Board of Supervisors of Robeson Township this 5<sup>th</sup> day of January 2026.
