A RESOLUTION OF THE TOWNSHIP OF ROBESON, BERKS COUNTY, PENNSYLVANIA, FIXING THE VARIOUS TAX RATES FOR THE CALENDAR YEAR 2026.

BE IT RESOLVED AND ENACTED, and it is hereby resolved and enacted by the Board of Supervisors of the Township of Robeson, that a tax be and the same is hereby levied on all real property within the Township of Robeson subject to taxation for the fiscal year 2026, as follows:

Tax rate for general purposes, the sum of 3.25 mills on each dollar of assessed valuation, or the sum of 3.25 cents on each one hundred dollars of assessed valuation.


The same being summarized in tabular form as follows:

That any Resolution, or part of Resolution, conflicting with this Resolution be and the same is hereby repealed insofar as the same affects this Resolution.



We are requesting that you complete the Municipal Tax information below and return it to the Treasurer's office by email to treasurer@berkspa.gov no later than December 26, 2025. This form authorizes the County to include municipal/township taxes/levies on the tax bill. It also gives the County the authority to bill your district for half the costs incurred in this tax billing and mailing process. If your district has special levies or taxes that do not apply to all parcels and require maintenance, all changes must be entered into the eCollections system no later than January 07, 2026. If your authorization is not received by December 26, 2025, no municipal/township tax will be included on the tax bill for your district for the tax year 2026.


INSTRUCTIONS FOR COMPLETING THE TABLE: COUNTY taxes will always appear on the first line of the bill. Please review all information currently on record for MUNICPAL/TOWNSHIP taxes/levies to be included on the Berks County Tax Bill. Taxes/levies will be listed in the first column with their respective millage/rate in the corresponding columns. If a tax/levy is applied to selected parcels, the "SELECT" column will be indicated. If you wish to add a new tax/levy, complete the table with the appropriate information and check the "NEW" column. If the new tax is for select parcels, please also check the "SELECT" column. Please note that there is a maximum of 8 levies. If a tax is to be removed, please draw a line through the item and initial that line.
