REGULAR MEETING MINUTES May 16, 2018

Chairman Smith called the Regular Meeting of the Board of Supervisors to order at 7:00PM prevailing time. The meeting took place in the Robeson Township Public Meeting Room located at 2689 Main Street, in Gibraltar, Berks County, Pennsylvania. All Board members were present. Also in attendance were Solicitor Christopher J. Hartman, Engineer Gary D. Kraft, Road Master Lanza, Chief of Police Mark T. Phillips and Township Manager Colleen A. Easterday.

Pledge to the Flag and Moment of Silence

GIRL SCOUTS

Doug Metcalf addressed the **BOS** about the GS refinishing the wooden picnic tables – Supervisor Steve moved to authorize the Girl Scouts to move forward with their service project. Supervisor Graham seconded the motion which passed unanimously.

ROADS / CODES / PUBLIC PROPERTY

Birdsboro Power / Dirt Donation – Chairman Smith moved to accept 4-5 loads of clean fill from Birdsboro Power; following a second by Supervisor Love, the motion passed on the following roll call vote:

Chief Phillips introduced new Robeson Township Officer Tyler Famous.

Chief Phillips & Engineer Kraft showed the design for the bicycle crossing signs for Robeson Crossing; plans will be submitted to PennDOT for review.

CITIZENS CONCERNS

Clyde Rodgers of 1377 Old River Road addressed concerns about rats coming from the White property, unmowed grass, trash on property, etc. Solicitor Hartman reported the property is currently being sold to another party.

Supervisor Graham moved to authorize Solicitor Hartman to allow to May 30th to see if the sale goes through; if not continue with legal action. Following a second by Supervisor Steve, the motion passed unanimously.

Supervisor Steve moved to have a letter sent to the current property owner to mow, etc., within 10 days from the date of the letter, if the current property owner does not comply with mowing the Township will lien the property for non-compliance and the Township will mow the grass and bill the owner for all costs including police presence if necessary. Following a second by Supervisor Love, the motion passed unanimously.

Supervisor Steve moved to authorize reimbursement to Tax Collector Carrie Mountz \$165.00 for an external hard drive to back up the Township Tax Records. Supervisor Graham seconded the motion which passed unanimously.

Clyde Rodgers complained about some local kids driving too fast on Old River Road. The BOS requested Engineer Kraft to research what sign would be appropriate and pricing.
