Field Use Contract

The Township of Robeson shall allow the use of sports fields for leagues/organizations that meet the following criteria:

- Township based league/organization always has first priority on all fields
 - All teams will be charged \$15.00 per game or practice
 - Willingness to work with other teams requesting the fields as to practice/game schedules, as well as fairly dividing responsibilities.
 - Tentative field use schedules are to be turned in to the township NO LATER than 2 weeks before start of season.
1. The Township will keep the grass cut on all fields, weather permitting.
 2. The Township will supply a trash dumpster and removal of trash from dumpster at our cost
 3. The Township will supply electricity to the concession stand at our cost.
 4. The Township will provide DiamondTex on an as needed basis at our cost.

The user understands and agrees to the following:

1. The user does NOT have access to the main building or the restrooms at Gibraltar Park.
2. The user will be responsible for keeping the infields dragged and "play ready" (baseball)
3. The user will be responsible for any necessary lining of the fields.
4. Porta potties will be provided. User equipment must be kept in a manner that will facilitate grass cutting during sports seasons.
5. User must remove all league/organization equipment, such as goals, batting cages, nets, etc. from park within 1 week of season's end.
6. User is responsible for making sure all trash is placed in large dumpster behind main building after each field use, including practices.
7. The Concession stand is available for league/organization use for a fee of \$25.00 per use, with the understanding that appliances within are township property and donated items are available "as is". User will bear responsibility for all league/organization equipment and/or food products etc. stored within the concession stand during playing season. The concession stand may need to be shared with another league/organization during any season; any food stuffs may need to be locked up accordingly. The Township bears no responsibility for equipment and/or food stuffs stored within the concession stand.
8. All league/organization property is to be removed from the concession stand and keys turned in within 1 week of season's end.
9. User understands that field use in wet conditions can cause safety concerns to players as well as damage to fields and will plan accordingly, canceling practices/games as necessary for wet field conditions.
10. User is expected to report any playground equipment damage or repair needed to the Township for obvious safety reasons.
