To our membership:

When our cooperative was established in 1932, the founding members wanted a better and more reliable provider of their needed supplies than was currently available. So a co-op is what they created.

The merger that created Centerra Co-op united two cooperatives with the aim of enhancing their individual ability to serve members. We confidently state that the goals of the Centerra merger have been realized: Our team is better trained, our equipment is more reliable, and our increased storage allows us to adapt to more volatile markets. Additionally, the range and quality of services we provide have improved significantly as a direct result of the merger. Importantly, we have been able to return twice as much cash to members through patronage and equity redemptions compared to before the merger.

The board approached the potential merger with Sunrise and Mercer by focusing solely on your needs as members. Our careful and thorough evaluation centered on identifying what is valuable to you today and anticipating how your requirements may evolve in the future.

We anticipate that the proposed merger will bring you new products and services, bolster our financial ability to invest in essential assets, and strengthen our negotiating hand in a consolidating vendor market. These three areas will be the difference maker for you and the cooperative, setting us up to come out of this ag cycle stronger than ever.

We encourage you to review this material, attend one of our many informational meetings, and ask questions.

We strongly recommend that you approve this merger of three strong cooperatives, creating a new cooperative that delivers the best possible value to your farm.

FAQs

Moving from three established entities into a single, stronger cooperative is a significant change for you. We encourage you to attend the information meetings but recognize that not everyone can get to one of these meetings. So, we created this FAQ to address your financial interests and operational needs. If you have other questions, please contact me at the number below.

Why are we merging now?

We are merging now because your cooperative is currently in a strong position, and we want to use that momentum to build something even better. By combining our resources today, we can accelerate our investment in assets of value to you, expand our reach, and offer you a wider range of services than any cooperative could provide as quickly on its own. It's about moving from 'good' to 'great' while we have the strength to do it right. This is about creating long-term reliability in products and services that support you today and tomorrow.

When and how does the vote happen?

We anticipate mailing you the ballot and additional materials in January or early February. We do not have an exact date for the ballots to be received, but anticipate that it will be in late February, after all information meetings are held. When we mail you the ballot, we will let you know the date that ballots will be counted. We will promptly notify you of the results.

When will the merger be effective?

If the members approve this merger, management of the three cooperatives will work diligently towards merging on the target date of September 1, 2026. However, this merger also requires government approval, which we will seek after your vote. We don't anticipate the government denying the merger, but we also don't know how long this approval will take. For this reason, please treat the September date as our goal, and not a certainty.

What happens if 1 of the 3 cooperatives does not approve the merger?

From Centerra's members' perspective, this merger requires the approval of each of the 3 individual co-op's members. If the members of Centerra do not approve the merger, Centerra will remain a separate co-op; it is possible that the other two co-ops merge without Centerra. If either Sunrise or Mercer members do not approve of the merger, Centerra will remain a separate co-op.

What happens to my current share and equity if the merger goes through?

Every existing common shareholder will have one share transferred into the surviving co-op. If you have shares in more than one of the three co-ops, after the effective date, you will receive a check redeeming the extra shares.

Your equity will be transferred \$ for \$ to the surviving co-op.

FAQs

Will my voting rights be affected?

The “one member, one vote”, which has been the foundation of co-ops, will remain firmly in place. The voting right of each common shareholder is unchanged.

Who will represent me on the Board of Directors?

The new board will consist of 3 directors from Centerra, 3 from Mercer and 6 from Sunrise. These positions will remain in place for 2 years following the effective date of the merger. After that period, normal elections will resume.

Will my local branch or elevator remain open?

Operations will continue as normal. Our priority is to maintain the convenience you’ve come to expect.

As you review the location material, you will notice the distance between branches doing the same business. The intent of this merger is not to close branches; instead the intent is to provide you with more access to what the co-op offers in a timely fashion. You have told us that you want a strong network of locations with superior speed, delivery capabilities, products and services. That is what will drive any future changes and enhancements to our location network.

Will I still work with the same agronomists, energy drivers, or grain originators?

The success of our co-op lies at the local branch where we work and serve you.

You will still work with the team members you know, but one of the most exciting parts of this merger is that your current team will now have even more resources and specialists behind them to support you. While your daily contact remains the same, they will soon be backed by a larger network of experts, allowing us to respond to your questions with more comprehensive solutions.

How will this merger improve my individual farm operation?

There are general and specific product/service advantages. The most important general advantage is the ability to hire motivated and talented people. In the last 5 years, we’ve not only replaced the huge years of experience that retired but also added to the number of people servicing your farm. As this generational rollover is still in progress, we need the programs and ideas for hiring and retaining great talent that each co-op is bringing.

Specific products and services that may be of benefit to you range from 0% input financing, PCT (foliars, biologicals and off-patent herbicides), beef and calf feeding programs with financing, more grain condo, and new grain marketing programs. This is just the start; more ideas will be rolled out as we take advantage of the new co-op.

FAQs

Who is the leadership team of the new cooperative?

As the boards explored this merger opportunity, they acknowledged the strengths that Mr. Secor brings as CEO, and agreed that he will be CEO of the new cooperative. Upon your approval of this merger, Mr. Secor will begin to identify the leadership structure and interview people for roles in the new cooperative.

Will the name of the cooperative change?

The name of the newly merged co-op will be the decision of the new board of directors. Part of the new board's decision will be considering the significant monetary advantage to maintaining the Sunrise Cooperative name. This monetary advantage comes from the fact that the specific name is grandfathered by law to allow the Sunrise cooperative to pay patronage on crop insurance.

INVESTMENTS

- Andover and Mansfield Grain - Substantial increases in grain storage, dryer capabilities, changes at pit, and overall unload speed, reducing wait times and allowing more bushels to come off farm at harvest.
- Andover Agronomy - Completely replaced bulk fertilizer facility and bagging line, more than doubling the space and reducing load out wait times.
- Smithville Grain - Added ability to load out rail cars, allowing for basis price increase. Also completely replacing and doubling Agronomy space for bulk dry fertilizer.*
- Bulk Lubricants and DEF - Reducing cost for products.
- Propane - Invested in bulk tanks, service trucks and delivery trucks at Middlefield, Andover and Volant, offering dryer gas to hundreds of additional farms and substantially reducing their residential heat cost.
- Centerra Connect - Customers can conveniently view account history, place orders, review and sign contracts, make payments, communicate and see status.
- Jefferson Fuel - Entirely replaced bulk facility, keeping fuel delivery service viable in Ashtabula and surrounding counties.
- Volant Agronomy and Feed - Added a drive-through warehouse, offering local customers a convenient pickup place.
- Sterling Feed - Extensive renovation and expansion of mill and warehouse, including addition of robotic bagging system.*
- Williamsfield Fuel - Completely replaced fuel island, adding the ability for local farmers to fuel directly into tractors, including DEF.
- Wooster Retail - Purchased new retail location to include indoor retail space along with expanded storage space and large drive through.*
- Loudonville, Middlefield and Sullivan Agronomy - Added bulk and packaged chemical storage buildings.
- Grain Condo Storage - Offered grain condo storage to members, selling all available bushels.

* A portion of these projects benefitted from local tax incentives to support economic development.

Additional grain bin added to Mansfield facility in 2021, increasing storage capacity by 1MM bu. to 5MM bu. at that location.

Next to the training we do for our employees to make sure they all understand that our customer-owners must win first, a close second is that we continually invest in our facilities to have first-in-class assets to continually improve our speed, space, and service. Our customer-owners are continuing to farm at faster and faster speeds and we must be able to sell and service our products and services at speeds that do not have them waiting on us.
