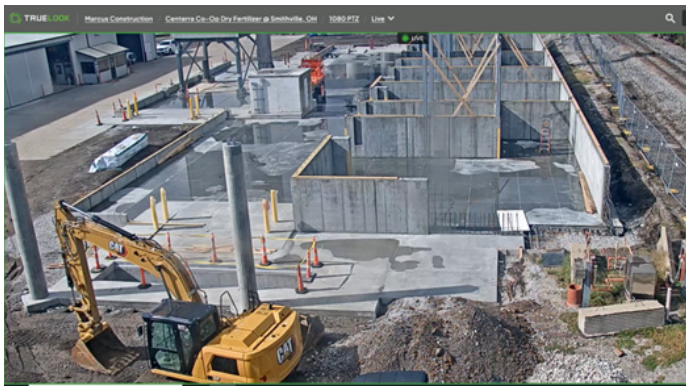

The new facility will house almost 4,200 tons of dry fertilizer and have an automated receiving system. The goal is to be in full operation for spring 2026. 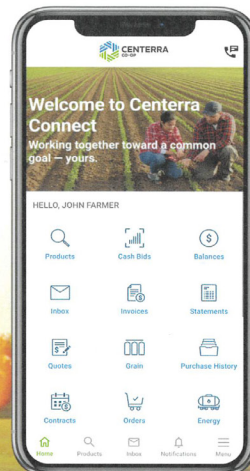
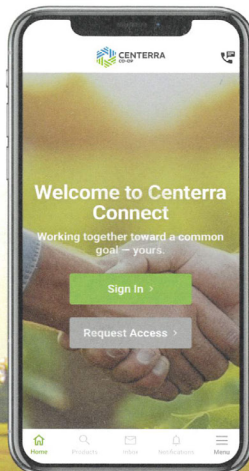
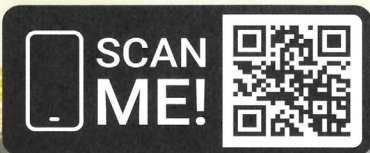
