Speaker-Natalie Wilson with GrayRobinson Law Firm, Elder Law Attorney Destiny introduced Natalie as Elder Law Attorney, practicing for 17 years here in Lakeland. She has never had a Medicaid application denied.

Natalie spoke on Probate Administration, and Lady Bird Deeds. Probate has 3 types of administration: Disposition, Summary, and Formal Administration. Disposition may be appropriate for personal property but no real estate, and the form for this type can be found on Polk County Clerk of the Court website. Summary Administration is for when the decedent has been dead for at least 2 years, and the estate value is less than seventy-five thousand. No personal representative is appointed but there is no cut off for creditor claims. Formal Administration is the full blown administration.

Make sure death certificate is accurate. A valid will must be witnessed by two people. Florida does not honor a hand written or oral will. Florida honors a valid written will if it is the original. If decedent was married, but has children from a prior marriage without a will, the current spouse would only get half of the assets, the children from former marriage the other half. If naming a personal representative, the personal rep must be a Florida resident or related by blood or marriage. A Lady Bird Deed (or Enhanced Life Estate), is a deed that the subject can add a beneficiary without giving up control during their lifetime. This is important during a Medicaid process.
