SUCCESS STORIES

Veterans come to MHVI for a variety of reasons.

Some never expected to need assistance. Darryl is one of those veterans. Early in the year, Darryl came to our office, distraught. He had served his country and worked a full-time job for years. But he found himself needing support from MHVI — due to a stroke, he was unable to work. Darryl is also a single dad of three daughters, one in college and two in elementary school. He wasn't interested in items for himself, rather his girls. MHVI jumped into action! Not only were we able to provide him with getting connected to some community services, but also were able to help stabilize his family by providing: • Emergency Food • Laptops for research and homework • Personal hygiene • Winter coats • Bikes • Gift cards • School clothing • Transportation assistance.

Shelby is an Army Veteran and single mother of two teenagers. Like so many people, Shelby lost her job due to the pandemic. To make things worse, she was fighting cancer and going through chemotherapy. Shelby came to our WOVIN program for assistance with her water bill, emergency food, gift cards for medication and transportation assistance. We provided support for 6-months to help stabilize this family by getting her basic needs met.

HOME SUPPORT MHVI provides everything a veteran needs to set up a household – furniture, household goods, bedding, and more. In addition to the many veterans who came into the office to get items they needed, we delivered household items to 169 veterans.

COMMUNITY EDUCATION & OUTREACH Despite COVID still being a factor in services, we still attended resource fairs, held events for veterans and provided educational sessions. In total 210 veterans were served.

EMERGENCY FOOD
PANTRY Ensuring veterans and their
families have access to food, our food pantry is
available to those in short-term crises. We are
excited that our offerings expanded to include
perishable items! A total of 705 food boxes were
distributed to 461 veterans.

BIKES FOR STRIPES

Helping veterans remove transportation barriers is important in them achieving goals. With donations of bicycles that are refurbished by volunteers, we gifted bikes, along with helmets and locks, to 83 veterans.

OTHER SERVICES


We understand veterans do not live in a vacuum and their families need services to help everyone succeed. In addition to the veterans, we served 112 spouse/partners and 193 children.
