SUPPLEMENTAL DECLARATION TO DECLARATION OF COVENANTS, CONDITIONS AND RESTRICTIONS FOR SIMMONS RIDGE

SIMMONS RIDGE JOINT VENTURE, a Tennessee joint venture composed of Coastal Development Corporation, a Tennessee corporation, and Simmons Ridge Partners, LLC, a Tennessee limited liability company ("Declarant") makes this Supplemental Declaration as of the 22nd day of November, 2021.

WHEREAS, that certain *Declaration Of Covenants, Conditions and Restrictions For Simmons Ridge* is of record in Book 6789, Page 125, Register's Office for Williamson County, Tennessee (the "Declaration");

WHEREAS, at Section 12 of Article I of the Declaration, Simmons Ridge Joint Venture, together with its successors and assigns, is defined and designated as the "Declarant" under the Declaration;

WHEREAS, the Declarant Control Period has not ended or otherwise terminated.

WHEREAS, pursuant to Article XII, Section 2 of the Declaration, Declarant has the right to amend the Declaration by the recording of this Supplemental Declaration in said Register's Office;

WHEREAS, Declarant desires to record this Supplemental Declaration for the purpose of amending the Declaration has hereinafter setforth.

NOW, THEREFORE, in consideration of the recitals hereinabove set forth, which are incorporated herein by reference, and other good and valuable consideration, the receipt and adequacy of which is hereby acknowledged, Declarant amends the Declaration as follows:

- 1. Article IX, Subsection 8 (b) is hereby amended to delete the phrase "an amount established by the Board from time to time" and replace the same with "One Hundred Dollars (\$100.00);
- 2. Article IX, Section 9 is hereby amended to delete from the second and third lines of the second sentence therein the words "the amount of the then applicable Start Up

Assessment, or if no Start Up Assessment has been established, the amount that could be imposed under Section 8 above" and replace the same with "One Hundred Dollars (\$100.00); and

3. Article XI, Subsection 1(x) is hereby deleted in its entirety and replaced with the following: "(x) <u>Leases</u>. Without the prior written approval of the Association, no Unit shall be leased for an initial lease term of less than one (1) year."

This Supplemental Declaration shall run with the land and be binding upon, and inure to the benefit of every person and party being subject to, and having an interest in the real property encumbered by, the Declaration.
